

This year we have two new projects that we are working on for our membership.

The first is a Judicial Reception to give appropriate recognition to our local judges for a job well done and to provide a forum for judges and lawyers alike in our organization to meet in a setting more relaxed than a courtroom. I think this is an idea whose time has come. The legal community in Broward County is expanding in a growth rate comparable to the rest of the county. We now have over 2,500 lawyers, approximately half of whom are members of the Broward County Bar Association.

More details on these projects will be forthcoming as we get past the planing stages, and I will keep you posted on them.

Next month, lunch is at the Bahia Mar Hotel. Come on over to see and hear Rick Horrow, the Director of the South Florida Sports Authority, who will be giving us the latest information on the proposed sports stadium and related projects. It should be most interesting.

#### 1982 LEGISLATION OF INTEREST TO THE LEGAL PROFESSION

(This is the second of a series on 1982 Legislation)

#### ADMINISTRATIVE LAW

HB 151—UNEMPLOYMENT COM-PENSATION. Provides that, in any administrative proceeding under the Unemployment Compensation Law, an employer or a claimant may be represented by an authorized representative or counsel. Amends s.443.151(7), Florida Statutes. Effective July 1, 1982. Chapter 82-178.

## CORPORATION, BANKING AND BUSINESS LAW

HB 3F - CORPORATE INCOME TAX. Allows corporations to elect to

report and pay tax under federal amendments to the Internal Revenue Code made between January 1, 1980 and January 1, 1982; removes real estate trusts from requirements of reporting under adjustments to taxable income; provides separate formulas to be used in computing the amount of corporate income tax due on installment sales; imposes an emergency excise tax which may be allowed as a credit against the corporate tax. This act shall take effect upon becoming a law. Chapter 82-232.

CS/HB 287 - BANKING. Creates Part II of Chapter 655. Deletes reference to periodic examination, provides an implementation schedule for semiannual fees paid by credit unions to the Department of Banking and Finance. It provides definitions, procedures for the conversion of a charter of a financial institution, limits conversions, requires application fees, provides for the merger or consolidation of capital stock financial institutions and mutual financial institutions, and provides that a financial institution may acquire the capital stock of any other financial institution. Effective July 1, 1982. Chapter 82-214.

HB 43 — CORPORATIONS. An act relating to corporations not for profit; repeals Part II of Chapter 617, Florida Statutes, relating to scholarship plans. This act shall take effect upon becoming a law. Chapter 82-177.

#### CRIMINAL LAW

HB 1137 — BAIL BONDSMEN. An act amending various statutes relating to bail and bail bondsmen. Redefines "runner," provides for applications for general agents' permits. In creases license fees and provides for a biennial licensing, changes requirements for application and qualifications for bail bondsmen and runners. Requires bail bondsmen to maintain records for three years for inspection by the Department of Insurance. Requires statistical reports from bail bondsmen and insurers. Effective October 1, 1982. Chapter 82-175.

SB 166 — RAPE VICTIMS. Requires the Bureau of Crimes Compensation to pay for medical expenses connected with an initial physical examination of any sexual battery victim. Provides for the confidentiality of records relating to such payments. Limits payments to a maximum of \$150 per violation. Appropriates \$1,020,000 from the gen-

eral revenue fund for the 1982-83 fiscal year. Creates s.794.07. Effective July 1, 1982. Chapter 82-192.

CS/SB 241 – PAROLE. Provides that a member of the Parole and Probation Commission or its duly authorized representative may sign warrants for the retaking of a paroled prisoner. Authorizes the Commission, a commissioner, or the Commission's duly authorized representative to determine whether to admit the alleged parole violator to bail. Provides for a preliminary hearing within 30 days of arrest. Amends s.947.22,23. This act shall take effect upon becoming a law. Chapter 82-193. SB 404 – CORRECTIONS. Adds correctional officers to the Bill of Rights for law enforcement officers. A m e n d s ss.112.531-534. Effective October 1, 1982. Chapter 82-156.

#### **ENVIRONMENTAL LAW**

HB 1016 – STATE LANDS. Provides the proceeds from the sale of state lands which are currently deposited in the Land Acquisition Trust Fund shall be retained in the Internal Improve-

ment Trust Fund and used for the acquisition, management, administration, protection and conservation of state-owned lands. Amends s.253.01 and repeals s.375.043. Effective July 1, 1982. Chapter 82-185.

HB 1066—RADIOACTIVE WASTE. An act creating s.404.30, Florida a Statutes. Makes Florida a party to the Southeast Interstate Low-Level Radioactive Waste Compact. This act shall take effect upon becoming a law. Chapter 82-186.

## HOUSING AND URBAN FINANCING

SB 340 - PUBLIC BONDS, Provides duties of the Division of Bond Finance of the Department of General Services with respect to general obligation bonds and revenue bonds of unit of local government and the state. Provides duties of units of local governments with respect to information furnished the Division regarding outstanding bonds and new bond issues. Deletes certain specific requirements with respect to a resolution authorizing a negotiated sale. Redefines "finder" and prohibits payment of finders' fees by financial advisers unless disclosure is made. Increases from ten to fifteen the number of yearly installments for payment of special assessments for municipal improvements and revises interest rates with respect thereto. Provides that improvement bonds be issued in the denomination of \$500 rather than \$100. Provides that certain water and sewer system bonds which are issued pursuant to special assessment provisions may carry an interest rate of up to one percent above that otherwise authorized by law. Amends s.218.37 and .38. Effective July 1, 1982. Chapter 82-195.

HB 346 — COURT CLERKS. Amends s.28.33, Florida Statutes, to provide that circuit court clerks shall retain 25% of all interest accruing from monies deposited in a court's registry; providing for allocation of remaining interest; amending s.197.291 (2), Florida Statutes, to correct a cross-reference; repealing s.28.24(14), Florida Statutes. Effective July 1, 1982. Chapter 82-117.

SB 881 — CLERK OF COURT. Amends s.28.24, Florida Statutes; to increase certain service charges; amends s.28.2401(1)(1), Florida Statutes, and adds a new paragraph (n) to said subsection increasing certain probate charges; amends s.28.241 (1), (2), (3), Florida Statutes increasing certain charges for trial and appellate proceedings; amends s.34.041, Florida Statutes; increasing certain service charges in county courts. Effective July 1, 1982. Chapter 82-205.

HB 8D — JUDICIAL EDUCATION TRUST FUND. Creates the trust fund for the education and training of judges, clerks, court administrators, and other judicial employees. The fund will be administered by the Florida Supreme Court through the Court Educational Council. Funded by an additional \$1 service charge on all civil actions. Amends s.25.384 and 28.241 (1), Florida Statutes. Effective October 1, 1982. Chapter 82-168.

HB 9D — WITNESS FEES. This is implementing legislation to allow the State of Florida to reimburse counties for witness fee expenses. The Appropriations Act contains \$2.7 million to reimburse the counties. This will not be enough to completely assume the yearly costs to the counties, but the State Courts Administrator hopes to begin reimbursing the counties in February 1983. Chapter 82-176.

#### **REAL PROPERTY**

HB 268 — CONDOMINIUMS. Allows a condominium association to charge a unit owner up to \$50 to cover expenses and services relating to the approval of the transfer, sale, lease, or sublease of such owner's unit by such owner. Provides the authority (if any) of a condominium association to approve certain transfers, sales, leases, or subleases, continues after control of the association is turned over to the unit owners. Amends s.718.112 (2) (j). Effective July 1, 1982. Chapter 82-113.

SB 634 — CONDOMINIUMS. Amends s.718.503 to specify the requirements for disclosure prior to sale apply only to residential condominiums. This act shall take effect upon becoming a law. Chapter 82-199.

#### WORKERS' COMPENSATION


SB 67 — WORKERS' COMPENSA-SION. Creates the Florida Self-Insurers Guaranty Association, Inc., and requires individual self-insurers, other than those which are public utilities or governmental entities, to be come members. Provides for withdrawal from the association upon termination of a self-insurance privilege.

Pursuant thereto it provides for a

Board of Directors, organization, operation, powers, and duties thereof. Creates an insolvency fund. Provides powers and duties of the Department of Labor and Employment security. Provides for exchange of information between the Board and the Department. Provides for examination and regulation of the association by the department. Provides for effect of paid claims. Provides certain immunity. Provides for a stay of proceedings. Provides a statute of limitations. The bill includes law enforcement officers acting within the course of employment for purposes of coverage. This bill became effective March 31, 1982. Chapter 82-65.

SB 655 — WORKERS' COMPENSATION. An act amending s.440.15(6) (b), Florida Statutes. This relates to compensation for hernia resulting from injury by an accident arising in the course of employment, to modify the period for which compensation is authorized. Effective July 1, 1982. Chapter 82-237.
