ANGELINE G. WEIR INSTALLED AS PRESIDENT

When Angeline (Angie) Weir was installed as President of the Broward County Bar Association on May 19, 1983, at Rolling Hills Country Club, she added another first to her long list of "First Woman to" etc. For instance, first woman Law Librarian of Broward County; first woman in Florida to hold the position as County Solicitor (of Broward County); first woman Associate Judge, City of Miramar, and the first woman to be Municipal Judge, City of Hallandale.

Now she is the first female to be President of the Broward County Bar Association. She may have been the first lawyer to pass the bar and become a mother, both within the same time period. Her daughter, Pam, is graduating this month from Nova College and plans to attend Nova Law School in the fall.

Mrs. Weir's list of awards include being named Woman of Achievement by the Business and Professional Woman's Club of Hollywood; Woman of the YEAR; LaViva Voce, Woman of Achievement; Florida Federation of Business and Professional Women's Clubs; Sun Tattler Appre-

ciation for News Boy Day Work; Award from Florida Highway Patrol; Outstanding Woman of the Year by the Broward County Italian American Civic League of Fort Lauderdale, and an honor award from the Fraternal Order of Police, Broward County Council.

At present, she is a Director, Atlantic National Bank of Hollywood; President of the Board of Directors of the Easter Seal Clinic, and is an Attorney-at-Law, 4600 Sheridan Street, Suite 401, Hollywood, Florida.

Mrs. Weir was born in Shenandoah, Pennsylvania, where she went to school until moving to Hollywood, with her husband, Robert, and entering the University of Miami where she received her degree of Juris Doctor. She was admitted to practice in June, 1960; and in July, 1960, admitted to practice in the United States Federal Court-Southern District. She was also admitted to practice in February, 1976, in the Supreme Court of the United States.

In addition to membership in the Broward County Bar Association, Mrs. Weir is a member of The Florida Bar; South Broward Bar Association; Greater Hollywood Bar Associ-

ation; Federal Bar Association; Law Library Committee; State of Florida Municipal Judges Association; and the American Bar Association. Other memberships include Hollywood Chamber of Commerce (past President of the Women's division); University of Miami Alumni Association; American Association of University Women; National Association of University Women; Florida Association of Women Lawyers; Altrusa of Hollywood; Kappa Beta Pi Legal Sorority; Women of the Moose; and the American Judges Association.

Robert, Angie and their daughter, Pam, live in Hollywood where they are active in social and civic affairs.

LAWYERS:

TRICKSTERS, HEROES, OR HELPERS?

Do lawyers want to be liked — or would they rather be feared and hated? That's what research attorney Marvin Mindes wanted to know. To find out he took a random sample of 626 people in a typical American community — 305 were lawyers and 321 were not. His surprising conclusions appear in the latest issue of *Bar Leader*, published by the American Bar Association.

Mindes says that lawyers actually have three public images: the macho "Hero," the sensitive "Helper," and the low-down dirty "Trickster." Attorneys, Mindes found, like to think of themselves in the "Hero" image: aggressive, intelligent, and successful. The public, on the other hand likes to think of lawyers in the "Helper" image: likable, understanding, and fair.

To illustrate his findings, Mindes points to the 1948 presidential election when the public chose the likable competent image of Harry Truman over the take-charge prosecutor image of Thomas Dewey.

Mindes' survey showed that the public thinks that only a minority of lawyers fit the "Trickster" image: manipulative, unethical, and egotistical. But most lawyers think the public lumps all attorneys into the Trickster mold.

According to Mindes, lawyers don't understand what the public really wants from them. "Lawyers generally do not recognize public expectations for them to be helpful, understanding, likeable — to be good guys." Mindes says. "Instead lawyers act on their misperception that people expect them to be tricky, overbearing, greedy, and cold."

Mindes suggests that lawyers stress human relations skills and stick to a strict code of ethics if they want to improve their public image. He thinks that the sharp rise in the number of women lawyers may help soften the image of the profession. Mindes concludes that "lawyers may have to decide whether they enjoy the picture of themselves as tough, macho gunslingers, or will accept a more mature role of helpful problem solvers who take responsibility for what they do rather than passing the buck to the client or the system."

SPECIAL MOTION

CALENDAR

FOR TEMPORARY PRETRIAL IN DISSOLUTION CASES

Effective immediately, the undersigned Judge will hear applications for Temporary Pretrial Relief in domestic matters by special appointments.

The following provisions apply:

1. FINANCIAL AFFIDAVITS are required.
2. Cases are limited to 10 minutes per side.
3. Counsel SHALL ALWAYS make appointments with the Judge's Ju-

dicial Assistant and shall notice the opposing party in accordance with applicable Statutes and Rules of Procedures.

4. A copy of the Notice of Hearing, Motion and Financial Affidavit shall be in the hands of the Judge's Assistant four (4) days in advance of the hearing (not just the clerk). This requirement may be relaxed if adequate notice is given to opposing party and if the moving party has copies of the Financial Affidavit in the Judge's Assistant's hands.
5. This calendar is intended for short Motions for Temporary Relief that require an evidentiary hearing and disposition within less than ten (10) days. Short procedural matters and Exceptions to the Report of the General Master may be set on the Judge's regular motion calendar from 8:45 A.M. to 9:30 A.M., (Monday thru Thursday). Lengthy hearing for Temporary Relief and those which do not require expeditious relief will not be heard on this calendar and may be referred to the General Master.


