Public Notice

With the aid and assistance of the Subcommittee of the Admiralty Law Section of The Florida Bar, the United States District Court for the Middle District of Florida has prepared, and is considering for adoption on February 1, 1986, a comprehensive revision of the Court's local admiralty rules.

The revised rules will be designated as Chapter Seven of the Local Rules of the Middle District of Florida, and will completely replace all existing local rules of practice and procedure governing admiralty and maritime actions within the Middle District of Florida.

Pursuant to Fed.R.Civ.P. 83, the Court solicits comments and suggestions on the proposed rules from the public and members of The Florida Bar. Copies of the proposed local admiralty rules are available for inspection during normal business hours at the Jacksonville, Orlando and Tampa Divisional Clerk's Offices.

To be considered, suggestions must be submitted in writing not later than December 20, 1985, to Mr. Donald M. Cinnamond, Clerk, Post Office Box 53558, Jacksonville, Florida 32201. The Court will consider the comments, make any appropriate changes to the proposed rules, and thereafter adopt a final version of the local admiralty rules.

Legislative Committee Report

Did you know? . . .

That filing fees for the District Court of Appeal and the Supreme Court have been increased to one hundred dollars per appeal as of July 1. In addition, the cost of preparation of the record on appeal has been changed from 50 cents per page to \$2.00 per document.

That under Florida Statute Section 465.017(2) as amended, pharmacy records relating to the filling of prescriptions and dispensing of medicine cannot be furnished to anyone other than the patient, his legal representative, the Department of Insurance or the spouse of the patient, if the patient is incapacitated. These records may be obtained by other parties in a civil or criminal proceeding only by issuance of a subpoena with proper notice to the patient.

That Florida law now provides that in a contempt proceeding relating to children under Chapter 39, the Florida Juvenile Justice Act, a child subject to detention is entitled to legal representation at all stages of the proceeding under Florida Stat. Sec. 39.412, as amended.

Survey Shows Lawyers Bill 35 of the 50 Hours They Work Each Week

Lawyers questioned in a recent LawPoll survey say they bill an average of 35 of the 50 hours they work each week, "about the same" as the other lawyers in their firm.

The survey, published in the October 1985 issue of the *ABA Journal*, shows that associates work a few more hours per week than partners, and that they bill a larger portion of their time. While associates work an average of 52 hours and bill 40 (77 percent), partners work an average of 50 and bill only 34 (68 percent). Sole practitioners bill the lowest portion of their time, only 30 of the 47 hours they work each week (64 percent), and large firm lawyers bill the most, 40 of the 52 hours they work (78 percent).

More than half the lawyers surveyed (57 percent) don't know how many hours associates are expected to bill or say there is no expectation. But according to those who do know, associates are expected to bill an annual average of 1,670 hours per year. Lawyers in business practices, larger firms and larger cities are most likely to be aware of billing expectations for associates.

These results stem from a LawPoll survey conducted for the *ABA Journal*.

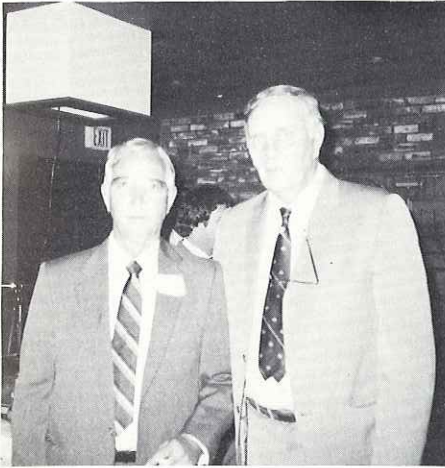

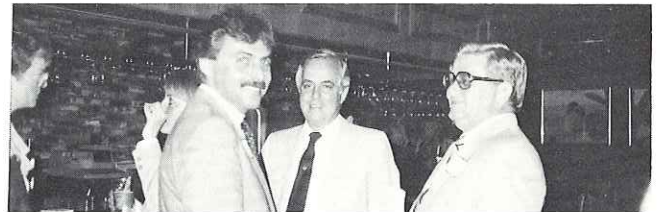

In Re: Court Reporter Fees

It appearing to the Court that Administrative Order 7.01.1 should be amended, in accordance with the provisions of Rule 2.070(e), Rules of Judicial Administration, it is

ORDERED that the schedule of Maximum Fees to be charged by the Court Reporters of the Seventeenth Judicial Circuit in criminal or juvenile proceedings where fees are paid with public funds are as set out hereinbelow and shall become effective immediately.

Original and one copy \$5.60 per page
Each additional copy .85 per page
