#### Additional 1980 Ad Valorem Taxes

On June 28, 1985, the Broward County Tax Collector began sending out tax bills for additional 1980 ad valorem taxes totalling approximately \$52,000,000 as a result of an Order of the Florida Supreme Court in the case of Florida Department of Revenue vs. William Markham. In 1980 the Florida Department of Revenue determined that William Markham, as the Property Appraiser of Broward County, had assessed the real property of Broward County, Florida, at less than fair market value and ordered a reassessment of the property on which to base the 1980 ad valorem taxation. Due to the fact that the reassessment could not be completed in time, the 1980 tax bills were based upon an interim tax roll comprised of the 1979 roll adjusted to the extent practical to reflect additions, deletions and changes of ownership, and to include new construction which would otherwise be placed on the final 1980 tax roll.

The Property Appraiser then petitioned the Circuit Court to enter an Order finding that it was in the best interests of the public to dispense with a reconciliation between the 1980 interim and final assessment rolls of Broward County, and to declare the interim roll to be the final tax roll for 1980. On June 5, 1981, the Circuit Court of Broward County, in Case No. 80-8271, entered an Order confirming as final the interim

assessment roll for the year 1980. This Order was reversed by the Fourth District Court of Appeal in 1983, and the reversal was upheld by the Supreme Court of Florida in 1985.

It appears probable that the lien for additional 1980 taxes would have attached to the property on January 1, 1980, even though it was impossible to determine the amount of the tax on any particular piece of property until approximately the middle of June 1985. The additional tax may be paid with a 4% discount until July 31, 1985. There will be no discount if paid in the month of August and penalty and advertising costs will be incurred if not paid until the month of September. Tax certificates shall be sold on the properties beginning October 2, 1985.

The billing of additional taxes has created a great deal of confusion among property owners and particularly those who have purchased property since 1980. The bills for additional taxes have been sent to the property owners of record as of 1985 and any refunds of overpayment of taxes will be sent to those who owned the property in 1980. A great number of the real property lawyers in Broward County feel that it is inequitable and possibly illegal to be taxing the present property owners for tax that should have been billed five years ago, if at all. A lawsuit has been filed on behalf of the

WHEREAS, the Executive Committee of the Broward County Bar Association unanimously believes that the imposition of additional taxes for this purpose is onerous to the citizens of this county; and

taxpayers of Broward County challenging the validity of the imposition of this additional tax and requesting a refund of the additional tax to any taxpayer who has paid it.

A special committee of the Real Property Section of the Broward County Bar Association has been formed to study and make recommendations concerning the additional 1980 ad valorem taxes. The committee fully supports the lawsuit which has been filed challenging this tax on behalf of the taxpayers and is working closely with Roger Staley and John Thabes, the attorneys representing the Plaintiffs in this action. The committee met with the Board of Trustees of Attorneys' Title Services, Inc., who have agreed to help finance the present litigation on behalf of the taxpayers of Broward County. The Real Property Section of the Broward County Bar Association would also request that all lawyers interested in the real property practice consider helping finance this litigation as well.

It is the concensus of the committee that unless a temporary restraining order is entered in the lawsuit restraining the collection of the tax that property owners should pay the tax in order to avoid the lien of tax certificates being issued on their property. It is also the concensus of the committee that on property which has been conveyed since 1980 that since the tax, if legal, became a lien on the property on January 1, 1980, that by virtue of warranties contained in Warranty Deeds and Mechanic's Lien affidavits, in almost every instance the seller of the property should be ultimately responsible to reimburse the purchaser for the payment of the tax. It is recommended that in paying the tax, a notation should be made on the check that the tax is paid under protest.

The committee further recommends that the attorneys of Broward County cooperate with each other and the purchasers of real estate in attempting to locate the sellers of the affected property.

All attorneys interested in the real property practice may want to monitor the progress of the case which has been filed contesting this tax, which is in the Circuit Court of Broward County, Case No. 85-16613 CR entitled Robert Hittel, Sr., et al., Plaintiffs, vs. Joseph Rosenhagen, as the Director of Revenue Collection, Broward County, Florida; and the Board of County Commissioners of Broward County, Florida, Defendants.

## **Assigned Alternate Judges** for Emergency Purposes

Procedure implementing Administrative Order 1.02.1, as amended July 1, 1985, regarding Assigned Alternate Judges for Emergency Purposes, Circuit Civil Division:

- 1. The attorney seeking emergency relief will determine that the Judge to whom the case was assigned is absent from the courthouse and is not expected to return for the remainder of the day.
- 2. The attorney will then go to the Court Administrator's Office (Room 880) with the motion requesting immediate relief, the Court file, and a brief written statement setting forth the reasons for the urgency.
- 3. A Deputy Court Administrator will:
  - (a) verify the absence of the Judge to whom the case was assigned,
  - (b) ascertain that the attorney has prepared a written motion and a written statement of urgency, and
  - (c) determine that the attorney has the Court file (or applicable portions of the Court file).
- 4. The Deputy Court Administrator will then assign an alternate Judge on a random basis.
- 5. The assigned alternate Judge will entertain the Motion at her/his earliest opportunity to determine whether an emergency situation exists and when such matter will be heard.
- 6. If the assigned alternate Judge determines that an emergency exists she/he will schedule such hearing at her/his earliest opportunity and enter appropriate orders. If the assigned alternate Judge determines that an emergency does not exist and the matter can be handled by the Judge to whom the case is assigned, she/he will note such finding on the assignment sheet.
- 7. The assigned alternate Judge will then return the Court file, together with the original assignment sheet and any notations thereon, and any original orders, to the Clerk's Office for docketing. She/he will send a confirmed copy of the assignment sheet by inter-courthouse mail to the original assigned Judge.
- 8. The attorney will send confirmed copies of any orders to all interested counsel and/or parties, where applicable.

#### **Conference of County Court Judges**

The Conference of County Court Judges is proud to announce the election of Judge Larry Seidlin as a Vice President and Judge Steven Shutter as a Director of the Conference of County Court Judges.

Broward County Judges Seidlin and Shutter were elected by the members of the Conference of County Court Judges of Florida at the Conference's statewide meeting in Key West on June 21, 1985.

The Conference of County Court Judges was established by law to be the official representative of all of Florida's two hundred and fourteen County Court judges.

One of the purposes of the statewide Conference is to advocate changes in the law for the benefit of the public, especially in matters regarding traffic laws, misdemeanor laws and small claims court laws. The Conference is particularly proud of its efforts this year in working with the legislature in securing the passage of Senate Bill 1183. This new law benefits good drivers by prohibiting insurance companies from raising insurance rates for minor traffic offenses and by providing for the withholding of points in many situations where a good driver has received a ticket and elects to attend defensive driving classes.

Senate Bill 1183 was originally conceived by Broward County Judge Harvey Ford, He and Broward County Judge Jack Luzzo were the principal Judges responsible for this bill's passage.

Judge William Herring (Broward County) successfully proposed and worked with the legislature this year in the passage of improved and simplified garnishment laws.

Broward's County Court Judges are prominent figures in the statewide Judiciary. Judge Ford is the immediate Past President of the Conference, Retired Judge Morton Abram was a recent President of the Conference and Judge Jack Luzzo has headed the Conference Legislative Committee for the past two years.
