



David Boies is a partner in the law firm of Cravath, Swaine & Moore in New York. He graduated Magna Cum Laude from Yale Law School in 1966. #### Law Day



## **Young Lawyers Section** President's Message

It's the 20th of October, 1986, the 20th being the deadline for articles to be completed and turned in to Bar headquarters to be included in next month's Barrister.

By looking through the October issue, which came in today's mail, I'm reminded that my article hasn't been written. Being the humble guy that I am, I first turned to the Young Lawyers Section of the Barrister to see how my last article looks in print and am reminded that last month, I missed the deadline and forgot to submit an article. It seems as if each month, as I hurriedly jot down some nonsense to meet the printer's deadline, I say to myself, "Next month I'll start early, work hard and pen an article of great importance, one that will touch and impact the lives of the readers." At one time, I wanted to devote an entire article to the lack of parking around the courthouse, the terrible elevator situation at 8:45 A.M., and the unbelievable waste of time and clients' money at "motion calendar." We attorneys spend too much time waiting at the courthouse-waiting for elevators that open on the first floor full of lawyers and judges who get on the elevators on the second and third floors and have no intention of getting off on the ground floor, but are, instead, on their way up. We wait for opposing counsel to arrive for "motion calendar" for motions they set for 8:45-you're there on time and they arrive at 9:20 and announce they have to go to another judge because their secretary set three motions that morning—that's great!

As long as I'm preaching, I might as well alienate the judges, too. How many times have you and your opposing counsel been in the judge's waiting room at 8:45 to have the judge arrive at 9:05, or even 9:20, and you look around the room and count 18 attorneys waiting for that

judge? Shame on you, judge.

Our judicial system is in a mess and we as attorneys and judges need to work harder to try to improve the system. Complaining about it is a start, but we need to do something about it. Judges who are consistently late should be disciplined, have their pay docked, or removed from the bench. Consistently late-arriving attorneys should likewise not be allowed to abuse the court system. Judges should discipline them or impose sanctions against them, or award opposing counsel attorneys' fees.

We attorneys should demand that our courthouse physical plant be improved; whether or not the bond issue passes (and it probably won't), we need better facili-

ties.

Last week, I overheard a lawyer from Tallahassee say during motion calendar

that he couldn't believe the way we run our motion calendar in Broward County; he called it a "circus." He's right, and the people of Broward County deserve bet-

#### A Letter to the Editor

Dear Editor:

Re: Instructing a witness not to answer during depositions as published in the *Broward Barrister*, October, 1986, Volume 15, No. 10.

I enjoyed the article in the last issue of the Barrister from David Welch as President of the Broward County Trial Lawyers Association. That article dealt with rules that are unspoken, unwritten, never cited and rarely questioned (UUNCRQ).

Almost all of what David said was not only funny, but quite true. I thought it would be to your readers best interest to provide some additional information concerning one of the UUNCRQ rules. David made reference to "invoking the rule as one that falls under this UUNCRO." It certainly falls within this classification as one that is rarely questioned (RQ) and never cited (NC), but does not fall within the other two criteria (UU). In fact, the rule that he is referring to is called the rule of sequestration. It is actually a rule that is invoked requiring the sequestration of witnesses. This is to be distinguished from the rules of procedure adopted by the Supreme Court and, in particular, Fla. R. Civ. P. 1.280(c)(5). Although the sequestration rule has never been crystallized in Florida as it has been under the Federal Rules of Evidence, it is a rule that has been spoken of and is written. I direct everyone's attention to Del Monte Banana Company v. Chacon, 466 So.2d 1167 (Fla. 3rd DCA, 1985); Dardashti v. Singer, 407 So.2d 1098 (Fla. 4th DCA, 1982); Spencer v. State, 133 So.2d 729 (Fla. 1961), cert. denied 369 U.S. 880, 82 S. Ct. 1155, 8 L.Ed. 2d 283 (1962). As the Spencer court stated concerning the "rule": "Ordinarily when requested by either side, the Trial Judge will exclude all prospective witnesses from the court room . . . to avoid the coloring of a witnesses testimony by that which he has heard from other witnesses who have preceded him on the stand."

I thought this might clear up at least one of these UUNCRQ rules.

By the way, I am forwarding a copy of this letter to David Welch and the Honorable Robert Lance Andrews for their additional summer reading material.
