


JOHN S. NEELY, JR.

John Neely was born in Tennessee and grew up in North Carolina where he attended Duke University and Duke Law School. He came to Florida in 1956 when he was admitted to the Bar and became associated with Fleming, O'Bryan and Fleming. He is now a partner in that firm, and has been a member of the Board of Governors since 1969. He has served on various committees of the Bar, including the Committee to Study Group

Legal Services and the Disciplinary Procedure Committee of which he was chairman under President Burton Young. He served on the Executive Committees of Presidents John McCarty and Reece Smith.

He is presently serving on the Executive Committee of President Earl Hadlow and the 1974-75 Budget Committee of President-Elect Jim Urban.

### Legal Aid Service

For many years the Broward County Bar Association has worked for a funded legal aid program. In 1973, the Bar was successful in its efforts. The Board of County Commissioners adopted an ordinance that provides a method of funding the program.

A non-profit corporation has been formed, and the Board of Directors have been designated. The board consists of fifteen members: five members of The Florida Bar appointed by the Board of County Commissioners, five members of The Florida Bar appointed by the Broward County Bar Association and five lay members elected by the top ten members of The Florida Bar. The members of the board are:

Five committees have been named, and they are:

Budget Committee, Carl Turner, Chairman; Committee on Personnel, James R. Holmes, Chairman; Committee on Facilities, James J. Blosser, Chairman; Committee on Eligibility, Harvey Ford, Chairman and Committee on Liaison, Joe Lewis Smith, Chairman.

The program will not release the Bar Association of its responsibility to help in the Legal Aid program, and cases will be assigned in the usual manner when needed.

### **Appeals Court**

Chairman Palm Beach County Appellate Court Advisory Committee

The Appellate Court Advisory Committee, after meeting with the Judges of the Fourth District Court of Appeal, makes the following suggestions in regard to filing appeals in that Court:

- 1. Discussion with the Judges revealed that brief-binders are actually taken off the briefs since the Judges find them cumbersome, and are eventually thrown away. Therefore, the Judges felt it permissible for briefs to be filed unbound and merely stapled securely in the left hand corner. This would save attorneys the time and money spent on securing binders, and save the Clerk's office the time spent in removing them from the
- 2. Discussion also revealed the Judges preferred that an original and two copies of each brief be filed in order that each Judge on the panel will have a brief from which to work. Although F.A.R.3.7 (a) (b) & (c) only requires the filing of one copy of the brief, filing two copies would be most appreciated by the Judges.
- 3. Because of an expression of concern on behalf of the committee, we were informed by the Judges that an attempt will be made to give criminal cases involving "Defendants-not-onbond" the most expeditious treatment of all criminal cases if an indication is made on the front of the brief in bold red letters "NOT ON BOND."

## Lawyer Referral Service By Henry J. Prominski

Referral Service has recently raised participation dues to \$35.00 per attorney, and currently the fee to the client for the first half hour interview has been raised to \$20.00. In this area of rapid growth with constant influx of new residents the Lawver Referral Service does a most commendable job and provides a real service to our new citizens. Every attorney is urged to participate in this program.

Although many of the initial referrals are of a domestic nature or of a legally non-stimulating variety, it is a service that should be provided by all members of the Bar and should be provided well. Attorneys participating should not feel that this is a service only for monitary rewards. All too often we are personal injury lawyers, tax lawyers, or other specialists, and really not lawyers at all. A lawyer should have his door open at all times for all persons for any legal problems that occur. We should be willing to give this time and talent to the public.

Recently a young girl was referred to me by the Bar Association with a problem collecting from Blue Cross for her accident. Not only did I obtain the Blue Cross coverage for her doctor bills, but upon closer examination discovered that where she completely had given up hope of assessing liability on anyone for the accident or collecting from any insurance carrier, there lurked in the background a secondary carrier. This coverage was uncovered after much work. However, it did provide a settlement of policy limits to a young lady who at that point was extremely dejected. If a lawyer can achieve one or two cases a year where he feels that substantial service has been done, it should be more than enough reward for participating in the Lawyer Referral Service.
