COURT DECISIONS

The recent case of Henley vs. City of Cape Coral 292 So. 2nd 410 upheld a municipal restriction for having trailers parked over four hours on a residential subdivision. Chief Judge Mann blithely stated that, although there may be circumstances in which the ordinances may be unconstitutional, there is a presumption in favor of constitutionality and that such a restriction is reasonable. No constitutional reasons were included for the enactment of this ordinance. There was no spelling out of health, safety and welfare, no delineation that this detracts from the esthetics of the community or that this interferes in any way with traffic. The court stated that commercial vehicles could be kept in a garage and of course this made it reasonable.

The famous needle on the beach case was also discussed in 294 So. 2nd 73. Here the owner of adjacent beach front land erected on presumably his own land a space needle - an observation tower for amusement by the payment of a small charge to have the thrill of riding high above the beach and observing the bathers and traffic below. The lower court held that since this area had been used by the public in conjunction with the public beach for many years and that the observation tower could not be properly built upon the land. The Supreme Court reversed in essence stating that, although the populous might have a prescription easement over the land of the defendant, the erection of an observation tower was inconsistent with the prescriptive use for public enjoyment.

Prepaid Legal Services

Thomas E. Kauper, Assistant Attorney General, Antitrust Division, U.S. Department of Justice, in a speech to the National Conference of Bar Presidents on August 12, 1974, stated that the Division on August 5 declined to issue a business review clearance of a proposed prepaid legal services program to a nonprofit organization sponsored by a state bar association which had adopted "discriminatory rules . . . similar to the Houston amendments" to the Code of Professional Responsibility.

On August 21, Mr. Kauper's Special Assistant, Joe Sims, appearing before the Committee on Professional Ethics of the New York State Bar Association, proposed specific amendments to the "Hou-

ston amendments" which, according to Sims, "would, in my view, largely eliminate the competitive and, thus, the antitrust, problems which the current rules . . . now pose."

In Honolulu, the ABA House of Delegates adopted a resolution creating an ad hoc study group charged with making recommendations to the House at its February 1975 meeting regarding the Houston amendments. In the resolution, the House suggested "to all interested entities that further action on the amendments be taken only with knowledge that the matter is scheduled for further consideration by the American Bar Association."

Legal Services Corporation

A large number of nominations reportedly are being considered for membership on the eleven-member board of directors of the Legal Services Corporation created by Public Law 93-355, signed into law on July 25, 1974. Since Senate confirmation of the nominees is required, it may be some time before the Corporation becomes operational.

Bert Gallegos, Director-Designate of the Office of Economic Opportunity, has announced that he anticipates making no substantive changes in the operation of the Legal Services Program while it remains in the OEO.
