#### FLORIDA BAR CENTER EXPANSION

The Board of Governors of The Flor-

ida Bar has approved a \$1.5 million expansion of the present Florida Bar Center located in Tallahassee. The Board of Governors has resolved that it would be preferable for the addition to be paid for by volunteer contributions from the members of The Bar rather than increasing the annual dues. The program is structured to accept \$500 pledges from individual members of The Bar payable over a period not to exceed five years.

The present facilities of the headquarter's office are not adequate to accommodate present programs for the membership nor to administer the additional programs for the membership of the future. Since the Bar Center was built in 1965, the membership has almost doubled to a present membership of 17,500. It is projected that by 1990 the membership will be 48,000.

#### NOVA UNIVERSITY LAW LIBRARY:

#### Services Available to Members of the County Bar

Special efforts have been made at Nova University to change the traditional pattern of law school libraries which often fail to provide lawyers with practice tools in addition to academic materials.

The Nova collection is being organized to obtain the best use of the legal material available and create a library that will serve not only our faculty and students, but also the practicing attorney.

At present the number of volumes in the library is over 30,000. The acquisition of the material was planned to exceed the requirements of the American Bar Association standards. The library contains basic research resources such as legal encyclopedias, restatements, citators, loose-leaf services and over one hundred periodical titles.

Special sections include publications concerned with Federal law, with sepa-



rate arrangement for a Tax collection and Administrative Agencies reports; Case law for the fifty states and statutory compilations for twenty-two states and a Florida section containing the Florida statutes (official and annotated editions) also the House and Senate Journals, the latest summaries and digests of legislation, Administrative Code, Florida cases, digest and encyclopedias, Slip decisions of the Florida Supreme Court and the United States Fifth Circuit Court of Appeals, and a number of texts, treatises, and form books dealing with Florida Law.

As an added service to the area lawyers, we are exploring the possibilities of establishing a Union Catalog of law libraries in the Broward-Dade area. This will locate at each library a complete index to the holdings of all the libraries in this area which will facilitate interlibrary loans.

At present the library is housed at the first floor of the Parker Building offering limited facilities to patrons, but the building of expanded quarters has already started with plans to have them ready for next September.

Visitors are welcome to register at the Nova Law Library and to offer sugges-



Senator Sam Ervin: In one of his first major public appearances since retirement from the United States Senate, Senator Ervin will address the Annual Banquet after the cocktail-combo party on Friday evening. "Country Sam" promises to offer a stimulating evening of politics and North Carolina charm.

General Practice Seminar: Sponsored once again by the General Practice Section of The Florida Bar, this will be a fast, hard-hitting session dealing with creditor's rights, foreclosure, bankruptcy, mechanics' liens, and other areas of law related to the current economic situation. has approached the Senior Board on several occasions in an effort to amend the rule requiring an attorney to have five years practice before appointment to an Ethics Committee. To date the Senior Board has rejected the proposal and at our recent meeting the YLS Board agreed to again approach the Senior Board with a proposal to reduce the number of years of required practice to two.

The Young Lawyers Section has recently instituted a procedure whereby it may submit Amicus Curiae Briefs, under certain strict conditions, to the Supreme Court and argue the Briefs in certain cases of particular interest to The Florida Bar and to the public in general.
