# Special Study Committee on Long Range Reorganization of Grievance Procedures

President James A. Urban appointed a Special Committee to study reorganization of grievance procedures. The committee will meet to hold public hearings around the state, and solicits comments and appearances from members of the Bar and the public on this important issue.

The committee has established four general areas of inquiry as follows: (1) Should confidentiality be waived following a probable cause finding at the grievance committee level? (2) Should The Florida Bar consider utilizing paid referees and/or Bar counsel in the disciplinary program? (3) What, if any,

role should non-lawyers have in grievance proceedings? (4) Should the function of the Board of Governors be delegated to a panel made up of members of the Board, to meet on a monthly basis, so as to expedite grievance procedures and relieve the full Board of these time-consuming functions?

Public hearings will be held at three locations on the following dates: (1) Orlando, Saturday, March 8, 1975, 10:30 a.m., Sheraton Towers, (2) Miami, Wednesday, March 19, 1975, 10:00 a.m., Columbus Hotel, (3) Tallahassee, Wednesday, March 26, 1975, 10:00 a.m., The Florida Bar Center.


Members of the press, interested laymen, all local Bar Presidents, experienced grievance defense counsel, and members of the American Bar Association Disciplinary Committee have been invited to attend.

The committee has decided to accept only written questions submitted prior to or during the three public hearings. The meeting will be tape recorded.

It is vital to the preservation of the good image of the Bar that a viable grievance procedure be adopted and followed. Your help as a member of this organization is necessary to insure that a full range of ideas will be presented to the committee members. Their report will be very influential on the Board of Governors when it is presented at the end of May.

A number of questions are inherent in the proposals: (a) if confidentiality is waived after a finding of probable cause at the grievance committee level, and the charge becomes public knowledge, of what use is the private reprimand? The Integration Rule presently provides for a waiver of confidentiality after a finding of probable cause in more serious grievance matters.

(b) Will any lawyers voluntarily serve as referees or Bar counsel on a voluntarily unpaid basis if the Bar pays some

lawyers and some referees in more serious cases? Can the Bar afford this additional cost without another increase in dues?

- (c) Is it necessary to involve nonlawyers in the grievance process to assure the public that the lawyers really do "clean up their own house?"
- (d) Do you prefer to have your grievance matters finally decided by a board of 35 lawyers, all of whom have been elected by the lawyers of the State of Florida, or are you willing to permit a smaller selected board to hear grievance matters in order to speed up the process which, by any standards, is far too long at present?

The foregoing commentary is not intended to be an expression of opinionmerely some reflections on the issues presented by the proposals which the committee will study.



# Reply From Gulfstream

The proposed new County administrative building was the subject of much discussion in Broward County during 1974. The debate concerning whether the administrative courthouse should remain downtown or move to a western site caused a great deal of misunderstanding with a number of attorneys and

the public in general. It is important that the misunderstanding be corrected as to what was involved in the "New Courthouse Location" discussions of last

The Broward County Commissioners did not intend to remove from the existing courthouse any of the judicial offices which presently are housed there, since a great number of attorneys' offices in town are located in the general area of the courthouse as well as some of the fine title companies in Broward County. It was the intention of the Broward County Commission to provide, whether across the street from the courthouse or in the proposed western location, those administrative offices such as the County Commission Chambers, the County Engineer, the County Administrator, the County Tax Collector, as well as the Tax Assessor. These offices normally deal with the public at large and to a lesser degree with local attorneys.

The problem was really one of semantics in that when people spoke of the "new courthouse" they should have been referring only to the new "administrative office" building and not to the "courts"
