COURT DECISIONS

Golden Loaf Bakery, Inc., vs. Charles W. Rex Construction Co., reported in 334 So2nd 585 involved a Writ of Certiorari on alleged conflict between the Districts. The conflict from the Fourth District Court arose from the dissenting opinion. The Supreme Court discharged the Writ stating in an opinion by Justice England in which Justices Overton, Sundberg, and Hatchett concurred, expressly overruled

the previous case of Commerce National Bank vs. Safeco, 284 So2nd 205 in which conflict jurisdiction was allowed on a dissent, apparently on the theory that the dissenting opinion set forth the only facts upon which the majority reached its decision.

In any event, the Supreme Court stating that the dangers in that practice far overshadowed any value that might be derived from any given case in continuing the practice of allowing certiorari when the conflict is between a majority opinion and a dissent of the District, overruled.

There was a dissent by Justice Robetts joined by Justices Adkins and Body, finding a conflict between the case on appeal and other decisions of a different district.

Professional Ethics Opinions

Advisory Opinion 74-41-Reconsideration

Upon a request for reconsideration, a majority of the committee recedes from that part of the opinion stating that publication of the author's name (when writing legal articles) and identifying him as an attorney are improper. We do so for the reasons stated in opinion 75-16.

Advisory Opinion 74-14

A law firm employs or has a partner as a part time assistant state attorney. A member of the firm inquires as to whether it may represent a public body in a bond validation proceeding "wherein the state attorney is served with process for response on behalf of the public". The assistant state attorney in the

firm will take no part in the bond validation proceeding.

The inquiry must be answered in the negative. If one lawyer in a firm is disqualified because of a conflict of interest, all lawyers in the firm are likewise disqualified. DR 5-105 D expressly so provides, CF., opinion 65-72. — (Emphasis added).

The population of Broward County was approximately 65,000.

The annual salary of Judges of Criminal Courts of Record in counties having a population of 50,000-175,000 was \$4,200. In counties having a population of not less than 70,000, the compensation of the county solicitor was \$4,200.
