The Broward County Bar, together with Nova Law School, jointly sponsored half day seminars at Nova University on January 21, 1977, on corporation, banking, and business law and on February 18, 1977 on family law, and both programs were well attended and well received by those present. A half day seminar on estate planning under the new tax law will be presented at Nova University on Friday, March 25, 1977, from 9:00 a.m. to 1:00 p.m., and the Committee expects to have an informative and well presented program at that time.

The Committee would like to thank Nova Law School, the Chairmen of the various sections of the Bar, members of the sections, the speakers and all those who have participated and assisted the Committee in presenting the above programs for the benefit of the members of the Bar Association.

in which they would like to specialize. A half-day seminar was presented by the Section on the Economics of Law Practice of the Broward County Bar Association to inform students about the expected role of the associate in a law firm, the attorney-client relationship and the potentials and pitfalls of the new lawyer. This seminar will be held again in the near future.

The Law Center has also begun a Continuing Legal Education Program in conjunction with the Broward County Bar Association. Short seminars have been presented on "Real Estate Syndication and Securities Regulation," "Federal Rules of Evidence," and, most recently, "Estate Planning Under the Tax Reform Act of 1976". The latter was so successful that it will be presented in seven cities throughout Florida over the next four months. Longer seminars will also be offered. The first was a half-day pre-

sentation on "Securities Law Considerations in Forming and Maintaining a Corporation"; four others are now planned on subjects of interest to the following local bar sections: Family Law, Real Property, Probate and Trust Law; Trial Lawyers; and Criminal Law.

Among the nineteen full-time faculty of the Law Center is the dean of the law school at the University of South Carolina, Robert Foster. Dean Foster is a visiting professor at Nova for the Spring semester and is teaching advanced courses in commercial transactions. He was the dean at the University of South Carolina from 1970 until 1976 and holds an LL.M. degree from Duke.

The Law Center has been collaborating with other centers at Nova University in interdisciplinary programs. One program is a seminar series held once a month on issues in science policy and law. Topics already covered include population control, recombinant DNA re-

search, and human experimentation in medical research. The panels for each of the seminars have been composed of the faculty from the Law Center and from the sciences. The seminars, which are open to the public, have attracted the attention of the media, resulting in newspaper and radio interviews with the participating faculty.

The Law Library of Nova University with its collection of over 95,000 volumes is open to the practicing bar and encourages its members to use the Law Library facilities by having allocated a small office for the exclusive use of the attorneys.

Though less than three years old, the Law Center at Nova University has begun to make itself felt in the community. It has brought together a well-rounded faculty committed to quality in legal education and looks forward to being a vital part of the Broward legal community.
