### Florida Bar Recommends Increase In Budget and Dues

At our regular Board meeting in Talahassee, the Board of Governors has recommended a Bar budget of \$6,178,-000.00 for 1978-79. This is an increase of about \$1,000,000.00 over the current budget,

The increases are proposed to be used primarily in the fields of Ethics and Discipline and an increase to the Clients' Security Fund.

Ethics and Discipline would increase by about \$750,000, while the Clients' Security Fund would increase by about \$150,000.

In order to carry out the increases in these areas, the Board has recommended to the Supreme Court that individual dues be increased from \$75.00 to \$125.00 annually. The proposed budget and dues increase will be presented to the Bar membership at the annual convention in June, and if approved, will be forwarded to the Supreme Court for its approval.

The Discipline fund has been increas-

BJELLOS, 346 So. 2d 635 (June 1, 1977). The Second District Court of Appeals remanded this case for a full trial in lieu of summary judgment, but at the same time it clearly established the rule that a closing agent has a legal duty which he will breach if he fails to inform the purchasers of a home that a negative termite inspection report has not been furnished when called for in the contract.

In BJELLOS, the Defendant was a title company and the Plaintiff was a home and title insurance purchaser. The property, unbeknownst to the purchaser, was infested by subterranean termites, treated, and guaranteed against further subterranean activity. At closing the Seller was given the guaranty, but a negative termite report was not supplied as provided in the contract.

Two months later a heavy infestation of drywood termites was discovered, the purchaser sued the closing agent, and the purchaser received a judgment for \$8,329.00 (subject to a full hearing as set forth above).

Since the new Broward County Deposit Receipt Contract, a copy of which was delivered to you with a previous issue of The Barrister, provides for numerous inspections which were not part of the printed language of the previous contract, every attorney who closes real estate transactions should study BJELLOS. It appears that it might be wise to receive a waiver from the purchaser for those inspections which the purchaser does not want and for which he will not pay.

This may lessen the effect of BJEL-LOS, but it will be interesting to see the course of future litigation in this area.

# Broward County Bar Fee Arbitration Committee

### Broward Bar Hears Complaints

Fee complaints or misunderstandings concerning fees can be resolved without costly litigation as a result of the Broward County Bar Associations' newly created fee arbitration committee. The committee is the product of efforts by the Broward County Bar to create a forum where prompt determination of fee disputes may be had without undue expense to the client or attorney.

Arbitration proceedings may be requested by either the client or the attorney. If both agree to the arbitration proceedings a \$20.00 charge for each is assessed to defray the administrative costs of the arbitration. In such instances, an award rendered by the committee may be enforced by a court with competent jurisdiction. Applications for arbitration may be obtained through the office of the Executive Secretary at the Broward County Bar Association (305) 764-8040.

### Malpractice Insurance-Self Insurance Special Committee Report

\* \* \* \* \*

The Special Committee on Malpractice Insurance submitted its report to the Executive Committee of The Broward County Bar Association, on March 8, 1978. The Special Committee was formed in response to alarming across-the-board increases in malpractice insurance premiums as well as the apparent failure of The Florida Bar to respond appropriately to an impending crisis in the legal malpractice insurance field.

As a result of the committee's efforts, a resolution was passed by the

Executive Committee and directed to The Florida Bar which called for action in the following areas.

The Broward County Bar Association has requested The Florida Bar to undertake whatever efforts are necessary to eliminate statutory prohibitions against the association of attorneys for the purpose of self-insurance. These prohibitions currently exist in Florida Statute 627.356(1) which requires, as a condition precedent to the association of attorneys for self-insurance, the non-availability of legal malpractice insurance from all insurers authorized to transact business within the State of Florida.

The Committee also determined that self-insurance by attorneys would only be feasible if attorneys enjoyed legislation similar to that enjoyed by physicians and currently embodied within Florida Statute 768.52 and 768.54, which created a "Patients' Compensation Fund". The "Fund", administered by the State, provides what essentially is excess coverage (over \$100,000.00) for self-insurance groups.

The Committee has as well determined that there is a real need to educate attorneys in the risk-management area and the resolution encourages. The Florida Bar to create aggressive risk-management programs and to make those programs a mandatory part of all CLE Programs approved by The Florida Bar for designation credit.

The full resolution, copies of which are available from The Broward County Bar Association, has been delivered to our delegation to The Board of Governors for consideration and appropriate action by The Florida Bar.

### APPOINTMENT OF ELISORS

Under Florida Statute 48.011 it is mandated that all process except subpoenas be directed to the Sheriff in the particular county when the process is to be served.

The Sheriff is authorized by statute to appoint special Process Servers also known as Elisors. In this county the Sheriff has not had the need to do so, so that an Elisor should not be appointed by a Judge in the 17th Judicial Circuit except where the Sheriff's Civil Division states that they are unable or will be unable to effect service.

It has come to my attention that Elisors have been appointed without following the procedure outlined above and has resulted in complaints by citizens to the Sheriff for actions by Process Servers not under his direction.

Please comply with the established procedure by directing an attorney requesting the appointment of the Elisor to either show a **return** indicating the Sheriff's inability to effect service or a document agreeing to the appointment of an Elisor.

All requests must be filed with the Civil Division of the Sheriff's department.
