#### ATTORNEYS' ALERT

## Agricultural Foreign Investment Act Of 1978

As reported in the July issue of the Real Property Probate and Trust Law Section Newsletter, this Act requires that all aliens who own or acquire, directly or indirectly, an interest in "agricultural land" must report such ownership by August 6, 1979 or such acquisition within 90 days of the acquisition. This report must be filed with the USDA (ASCS) local office in the County where the land is located.

The penalty for violation is up to 25% of the value of the interest. For further details see 7 USC §3501-3508 and 7 CFR §781.

#### **OPINION HEADNOTES**

OPINION 76-11 December 19, 1977

It is ethically improper for attorneys who share office space and secretarial services to hold themselves out as a partnership unless they are in fact partners.

An attorney whose practice includes criminal defense work and who shares office space and secretarial services with other attorneys who are part-time assistant public defenders, may continue such an arrangement if the Public Defender's Office refers persons who do not financially qualify for its services to a Lawyer Referral Service, rather than to individual private attorneys.

# Report of the Meeting of the Board of Governors July 1979

The Board of Governors of the Florida Bar met at Captiva Island on July 12, 13, and 14, 1979.

spent in executive session for the consideration of disciplinary actions and the administration of necessary private reprimands.

This was the first meeting presided over by the new president of The Florida Bar, L. David Shear. President Shear welcomed nine new members of the Board of Governors, including Drake M. Batchelder from the Seventeenth Circuit. President Shear indicated that he would soon institute a new procedure for reporting attendance of Board members at Board of Governors meetings in the Florida Bar News.

After nominations, discussion and an election, three nominations for each of the two vacancies on the Florida Board of Bar Examiners were recommended for selection by the Supreme Court.

Former President Ed Adkins in behalf of the Long-Range Planning Committee announced that it would hold a retreat March 28 through 30 of 1980 by a group of from 90 to 125 participants, to consist of 70%-80% lawyers and the rest laymen. The aim is to have a good mix from lawyers throughout the state, with only a maximum of 10 (probably 5 to 7) members of the Board of Governoors. The site currently under consideration as the most likely meeting place is Dodgertown in Vero Beach. The purpose of the retreat will be to come up with a workable long-range plan.

Several new plans for prepaid legal services were approved.

Several members of Judicial Nominating Commissions were elected, including Marjorie Gadarian, who was elected to serve on the Nominating Commission for the Fourth District Court of Appeal to replace Fred Ward from Orlando, who will go out of office once the Fifth District Court of Appeal is established.

The new Florida Juvenile Procedure Rules were approved by the Board of Governors with the exception of an amendment inserting "mental retardation" in rule 8.170.

An amendment to the standing policies of the Board of Governors was passed permitting any number of the Bar to submit his name directly to the executive director for consideration for nomination for any position elected by the Board of Governors when a vacancy occurs and, further, provide maximum periords of service generally geared to preclude the perpetuation of persons in office in any position and setting limits on the term which they can serve.

A recommendation of the Budget Committee that expenses of Board of Governors members be reimbursed commencing July 1, 1980, was defeated by a a substantial vote.

Action was taken to change the name of the Workmen's Compensation Section to "Workers' Compensation Section" in compliance with the new designation for this field established in the last session of the legislature.

Immediate past president, Robert L. Floyd, was elected by acclamation as The Florida Bar's delegate to the House of Delegates of the American Bar Association.

The Disciplinary Review Committee recommended that a "model plan" for fee arbitration be routed to local Bar presidents for their input for later consideration by the Board of Governors. It appears imperative that such plans be adopted on a statewide basis to comply with the expressed desires of the Supreme Court.

A proposed amendment to the integration rule was adopted and recommended to the Supreme Court to provide for the notification of partners, associates, and employed attorneys of any alleged violations involving the trust fund of a law firm.

A new by-law 11.11 was adopted to comply with the new wording of the Supreme Court's order on the Karl Committee report pertaining to petitions for reinstatement to membership.

At the request of the Circuit Judges' Conference, it was decided to set up panels of volunteer lawyers in the various circuits to represent judges involved in any orders limiting press coverage on trials, or appeals therefrom, resulting from the new procedure established by the Supreme Court for immediate appeals by the press. We will be calling on our fellow attorneys to serve on these panels and would welcome any names volunteered or suggested for such service. These panels are to be established by

Ron Richmond of New Port Richey gave the report of the Unauthorized Practice of Law Committee and procedures were considered to more expeditiously dispose of the 235 cases currently being investigated at the circuit level throughout the state. We will be meeting with the local committee chairmen regarding this.

The Board authorized President Shear to attempt to find federal funds for a study to determine ways to provide better legal services to indigents as mandated by the Supreme Court and authorized the use of \$17,500 for such a study if federal funds cannot be located.

President Shear announced the ap-

pointment of Mike McNerney and Judge Hugh Glickstein, both of our circuit, to the coming year's Budget Committee. This is a very important committee, and we are happy to have such fine representation from this circuit.

President Shear announced that as soon as details can be worked out, Poe and Associates will be mailing out the prospectus for the issuance of 6 percent debentures to fund the Florida Bar's new reciprocal self-insurance program. It is imperative that we support this program and purchase these debentures in the amount of \$300 each to permit us to become self-insured for malpractice insurance.

Certain changes asked by the Environmental Law Section in its by-laws were approved by the Board.

In the last item of business, the president of The Florida Bar was authorized to contact the Florida Bar Examiners to see if they wish to file an amicus brief in the Dasher case, which involved a ruling of a Federal District Court that a graduate of a law school not accredited by the American Bar Association could not be denied the right to take the Bar exam. If the Bar Examiners do not elect to file an amicus brief, the president was authorized to designate someone to file one in behalf of The Florida Bar. This case does not involve The Florida Bar examination, but could have wide-reaching effect on all state Bars.

### Procedural Tips and Queries

## Writ of Possession Against Bankrupt

Tenants Ms. A and Mr. B (a single man and single woman living together), were three months delinquent in rental payments. Suit was brought in Palm Beach County Court for eviction and damages, Mr. B. filed a Suggestion of Bankruptcy in the suit. Ms. A did not. The complaint was amended to seek damages from Ms. A. only and eviction of both tenants. Landlord's Proof of Claim was filed in the U.S. District Court against Mr. B. Counsel for Defendants in County Court then stipulated to issuance and service of a Writ of Possession against and on Defendants. The County Court ordered issuance and service of the Writ.

The Palm Beach County Sheriff's Department refused, on advice of its counsel, to serve the Writ on Mr. B. serving only Ms. A.

Sheriff's counsel maintained that while Bankruptcy Rule 401 appears to be

worded so that the automatic stay applies only to collection of debts or prosecution of liens, the stay currently being issued by the U.S. District Court is broad enough to encompass evictions: Badger Lumber Coo. vs. St. Louis-San Francisco Ry. Co., 89 S.W. 2nd 954, 338 Mo. 349 (permitting ejectment where no judgment for damages was sought) was decided under the prior language of the Rule; the U.S. District Court's Stay takes precedence over the County Court's judgment of Eviction; Defendants' counsel cannot by Stipulation waive the rights of the Trustee in Bankruptcy, and Plaintiff's remedy is to apply to Federal Court for a dissolution of the Stay for the particular purpose of the eviction of Mr. B.

A spokesman for the Broward County Sheriff's Department, Civil Division, stated that in Broward County, the Writ against Mr. B. would be posted, but not executed.

Again the questions are those of basic fairness and interpretation of law. Do the current Federal Court stays comply with the intent of Rule 401? Are the Sheriff's Departments justifiably fearful of a suit by the Trustee in Bankruptcy or of contempt proceedings in Federal Court? Does prevailing procedure unduly and unnecessarily restrict landlords
