Forida Rules of Judicial Administration

RULE 2.070 (f)

- (f) TRANSCRIPTS. Transcripts of all judicial proceedings, including depositions, shall be uniform in and for all courts throughout the state. The form size, spacing method of typing transscripts are as follows:
- (1) All proceedings shall be typed or printed on paper 8½ inches by 11 inches in size, prepared for binding at the top or on the left side margin.
- (2) All margins, measured from the edge of the paper, shall be no more than one inch from the top, no more than 1½ inches at the left side and ¾ inch at the right side for type or print of nine characters to the inch, and no more than 1¾ inches at the left side and ½ inch at the right side for type or print of ten characters to the inch.
- (3) There shall be no fewer than 25 typed characters or printed lines per page and all typing or printing shall be double spaced, with all lines numbered 1 through 25, respectively, and with no more than a double space between paragraphs.
- (4) Type size or print shall be pica or comparable type or print of no fewer than nine or ten characters to the inch.
- (5) Colloquy material shall begin on the same line following the identification of the speaker, with no more than two spaces between the identification of the speaker and the commencement of the colloquy. The identification of the speaker in colloquy shall begin no more than ten spaces from the left margin, and carry over colloquy shall be indented no more than five spaces from the left margin.
- (6) Each question and answer shall begin on a separate line no more than five spaces from the left-hand margin

with no more than five spaces from the left-hand margin with no more than five spaces from the "Q" or "A" to the text. Carry-over question and answer lines shall be brought to the left-hand margin.

- (7) Quoted material shall begin no more than ten spaces from the left-hand margin with carry-over lines beginning no more than ten spaces from the left-hand margin.
- (8) Indentations of no more than ten spaces may be utilized for paragraphs and all spaces on a line as herein provided shall be utilized unless the testimony of the speaker ends short of marginal requirements.
- (9) One-line parentheticals may begin at any indentation. Parentheticals exceeding one line shall begin no more than ten spaces from the left-hand margin, with carry-over lines being returned to the left-hand margin.
- (10) Individual volumes of a transcript, including depositions, shall be no more than 200 pages in length, inclusive of the index.

This rule was effective 12:01 A.M., January 1, 1979.

Report of the Meeting of the Board of Governors of The Florida Bar

The Board of Governors met in Tallahassee on January 17, 18 and 19, at The Florida Bar Center.

Grievance matters were perhaps the most relevant of the subjects discussed. Specifically, two new Grievance Committees for the Seventeenth Judicial Circuit were appointed so that there are now six such committees, A through F, which will be functioning in accordance with the requirements of the Supreme Court.

Further, the two staff counsel of The Florida Bar who are now located in the Bar's office in Fort Lauderdale will be serving as Bar Counsel in the matters coming before the newly appointed committees.

The Grievance Agenda, during which the Board sits in Executive Session, was so considerable that almost a full day was spent in discussion of pending matters. Several private reprimands were administered.

Another matter which has been of substantial concern to the Seventeenth Circuit is the ever increasing expenditures by the Bar. To reckon with this problem, the Board retained a major accounting firm to determine whether the employment of an internal auditor responsible to the Board, not the staff, was advisable; to identify the problems with the existing budgeting procedures and internal financial reporting; and to recommend solutions to the problems.

The legislative report of LAWPAC reflected that of the 49 lawyers it supported in the recent elections, 26 won; and that of the 52 non-lawyers supported, 38 were elected.

An enormous amount of time was spent in discussion of which representative should be endorsed by The Florida Bar for malpractice insurance as well as the implementation of the Bar's reciprocal program which would be similar to that used by the doctors of Florida. The Board voted to endorse Lawyers Professional Liability Insurance Co., which will now be competing with Poe & Associates in the marketplace.

The Board approved the joint sponsorship of The Florida Bar and the Department of Insurance of the Legal Expense Insurance Act, a pre-paid legal services insurance program.
