Notwithstanding, the presence of all these things, solutions almost always require another ingredient. . .



Improvement of the administration of Justice almost always requires this essential ingredient.

The Florida Supreme Court recently approved a program which provides a new source of funds to improve the administration of justice. This is the Interest on Trust Accounts Program.

The program allows funds in attorneys trust accounts to be placed at interest with the money to be used to fund programs for Legal aid, law student loans and scholarships and programs to improve the administration of justice. The rationale is that deposits of clients placed in such accounts are

generally small in amount or held for a relatively short period of time. Therefore, it is not practical to place the funds at interest and allocate it to the client.

Now, instead of allowing these funds to remain in a checking account earning no interest, such deposits can be placed in a NOW account with interest to be used for these public and charitable purposes.

The interest is paid to The Florida Bar Foundation, Inc. The Foundation has operated continuously since 1956 supporting just these types of programs. It will continue to do so under the supervision of The Florida Supreme Court. In addition, the Foundation's member-bership has been expanded to include all lawyers participating in the Interest on Trust Account's Program.

The timing of the program is superb. It has become available just at the time when public funding sources of all kinds are being reduced for a variety of reasons. The needs are ever present and ever more costly. We can help meet the needs from this new funding source.


The program is simple and effective.

It involves no additional record keeping over and above what is now required. All you have to do is:

- Tell the bank to make your trust account a NOW account.
- Have the bank send the interest to The Florida Bar Foundation, Inc., Tallahassee, Florida 32304.
- Have the bank send year end interest statements to the Florida Bar Foundation, whose tax identification number is 59-1004604.

I join the Chief Justice of Florida, the Attorney General of Florida, the President of the Florida Bar Foundation and a host of other Bar leaders, in urging your participation in the program.

FEDERAL COURTS COMMITTEE REPORT

The Southern District of Florida is participating in a pilot program regarding the implementation of the Devitt Committee recommendations to set minimum standards for admission and practice in the United States District Courts. A proposed set of rules is circulating among the members of the court. These proposals, which have not been voted upon by the judges, could go into effect as early as January 1, 1982. It is believed that the proposed rules will be adopted without major modifications by the court.

Under the proposed rules, an attorney will be qualified for admission befor the court if he or she is currently

admitted to practice in the state courts and has passed an examination covering knowledge of the Federal Rules of Criminal Procedure, Federal Rules of Evidence, Federal Rules of Bankruptcy, federal jurisdiction and venue, and Local Rules. This examination will be administered six times a year by the clerk of the court,

Lawyers presently admitted to practice before the United States District Court will be "grandfathered" into the General bar of the court. Admission to the General bar does not confer the right to appear alone on behalf of a client during testimonial procedures. An attorney must be admitted to the Trial bar of the court or if a member of the General bar, be accompanied by a member of the Trial bar. Testimonial proceedings are defined as proceedings in which oral testimony of a witness is taken before the court of the magistrate (this does not include depositions).

Membership in the Trial bar is not automatic for lawyers presently admitted to practice before the court. In other words, there will be no "grandfather-

I certainly hope that this year's cochairmen of the race, Rich Wagenheim and Jim Morgan, will again serve as the anchor for the YLS organization, Anyone who participated in the race itself. assisted in conducting the race or read the accounts in the newspapers is aware of the tremendous effort and achievement effected by Rich and Jim. In that regard, they have each requested that I solicit members of the Young Lawvers Section to determine if there is interest in the section at large to sustain the continuing needs of the YLS United Way Run. I would appreciate it if you are interested in working on next year's race, that you contact me in writing so the plans can begin for next year's race.

In light of the tremendous benefit to the local Broward County United Way campaign and its beneficiary agencies, I think that the event deserves your time and support.

YOUNG LAWYERS SECTION BOARD OF GOVERNORS REPORT

The Young Lawyers Section of The Florida Bar met in Gainesville for its November meeting, held on November 13 and 14, 1981. Key topics for discus-

sion at this meeting were a report on the current status of proposed rules for the Northern and Southern Districts of Florida, report and discussion relating to the model rules of professional conduct (Kutak Report), a report from the judicial relations committee concerning the Young Lawyers Sections Clerks for Judges Program, review and discussion of The Florida Bar's lawyer referral system and its statewide pro bono referral system, a review and up-date of the "Bridge the Gap" seminars and basic practice seminars of the Young Lawyers Section, review and discussion of the Section's Job Fair Program, review of the status of the Section's Lawver's Handbook, and a review of the Local Section Liaison Committee's Local Section Handbook and plans for this Committee's Outreach Meeting at the Young Lawyers Section Convention to be held in April of 1982.

The next Young Lawyers Section Board of Governors Meeting is scheduled for February, 5 and 6, 1982, and this meeting is to be held locally at the Marina Bay Resort in Fort Lauderdale. The Broward County Young Lawyers Section will be hosting this Board Meeting, and persons desiring information regarding the topics for discussion and the timing of the various reports and functions should contact any of the three local members of the Board of Governors, Bill Davell, Jesse Faerber or Jim Davis.

OVER 900 RUN FOR UNITED WAY

The second annual Young Lawyer's/United Way 10 Kilometer Run was held on Saturday morning, October 31, 1981. The race was a great success with approximately one thousand entrants. Over nine hundred runners actually finished the race which was held in Sunrise, Florida. The overall winner in the male division was Jimmie Butler with a time of 33:02 and the overall female winner was Cynthia Raes with a time of 39:08.

There was a separate lawyer's division with approximately thirty or forty lawyers and judges participating. The first, second and third place finishers in the Lawyer's Division were, respectively, Clinton Tarkoe, with the time of 37:20; Roger Howard with a time of 40:46 and Robert Fine with a time of 41:45. Rob Carney, of the Broward County State Attorney's office, finished

close behind these gentlemen with the time of 42:04,

The Run Steering Committee extends its thanks to all the lawyers and assistants who helped organize and put on the run and a special thanks to Judge Lawrence Korda who was the official race starter and assisted in award presentations. Although the final figure has not yet been determined, all proceeds from the run go to United Way.

ing" into the Trial bar. Each attorney desiring to be admitted to the Trial bar must satisfy the trial experience requirements of the court. These requirements may be met, in part, by observation of a qualified trial or qualified jury trial, or by simulation units obtained in law school clinical programs approved by the court, or by participating in a certification program such as that operated by the National Institute of Trial Advocacy. In general, the four required units of trial experience must include at least one participation unit (in a testimonial proceeding on behalf of a client), one participation or observation unit in the United States District Court for the Southern District of Florida, and one for participation or observation unit in a qualifying jury trial.

Thus, under these rules, state Circuit Court trial experience as well as non-jury trial experience, will count towards the meeting of the necessary four units.

The plan anticipates that each lawyer desiring to become a member of the Trial bar will certify to the Clerk the requisite number of trial units together with the name of the party involved, the court, and the dates. Forms will be provided by the Clerk's office for this purpose.

The Trial bar rules will not be in effect for the first six months of the pilot program. During this period of time, it is presumed that the Clerk will be certifying and enrolling members into the Trial bar. This administrative process, particularly in the initial stages, will involve some delay.

The final feature of the pilot program is peer review. A peer review committee, composed of one lawyer appointed by each judge, will be created. A district judge may refer any lawyer to the committee whom the judge has observed practicing law "in a manner which raises a significant question" as to the adequacy of the attorney's ability to represent clients in a competent manner. The judge shall also give a statement of his reasons for referral.

The committee has broad power to implement remedial measures, including mandatory CLE programs. However, only the court may act to restrict any lawyer's appearance before it.

The Committee on Federal Courts of the Broward County Bar Association is presently reviewing the proposed rules and will report to the Executive Committee at the December meeting. Copies of the proposed rules are available at the Broward County Bar Association for review by individual attorneys. Anyone wishing to submit comments on the proposed rules should address them to G.
