### ECONOMICS COMMITTEE PLANS SEMINAR

The Committee on Economics and Management of Law Practice of the Broward County Bar Association has scheduled their first annual seminar for Friday, May 1, 1981.

The highlight of the program will be a panel presentation by experienced practitioners in designated areas who will share their secrets and techniques for running a profitable operation. If you have been wondering how some attorneys in town are able to practice so much more profitably than others, this may be your chance to find out.

The program will also include presentations on simple but efficient docket control systems and accounting and management systems.

The creation of a landlord/tenant practice system will form the basis of a discussion on how to systemize routine legal procedures such that they can be handled efficiently and profitably.

### PRESIDENT'S REPORT

During the past several years, I have attended leadership conferences where I have met Presidents and other officers of Bar Associations. We considered and discussed the many problems which the Bar Associations and the members of the Bar are facing. Many of these problems may well affect the practice of law in the future.

A recent example of this is an attempt by the Federal Trade Commission to subject attorneys to the Commissioner's jurisdiction. Wm. Reece Smith, Jr., President of the ABA, spoke to the members of the Broward Bar at a past dinner meeting of the FTC's attempt to assert jurisdiction over the regulation of attorneys and urged the Bar Associations to fight the mandatory questionnaires which the FTC was seeking to compel all Bar Associations to answer. As a result of the objection of President Smith and the Bar Associations, the initial attempt was defeated, but it is anticipated that further attempts will be made in the future. Justice Alan C. Sunberg has advised The Florida Bar that "it is the considered judgment of the court that The Florida Bar should respectfully decline to respond to the voluntary questionnaire" of the Federal Trade Commission.

tory pro bono service by every attorney. The suggested rule would require each attorney to provide pro bono service to the poor as a condition on the privilege of practicing law. President Smith has suggested that pro bono service should remain on a voluntary basis, with the Bar Associations assisting the poor with their legal needs. Another area of recent concern is the attempts by lay persons to enter into the practice of law by the use of stock ownership of legal clinics. The Florida Supreme Court has entered a decision prohibiting such practice, but it is anticipated that further attempts will be made by non-attorneys or corporations to engage in the practice of law.

Another area of concern has been the extent of advertisements allowed legal clinics or attorneys in the practice of law. Recently, the New York Courts have held that attorneys may write letters to prospective clients as permissible advertisements, even though they were not acquainted with those persons and they were offering to perform future legal services. A similar case is pending in Dade County, Florida. The extent and effect of advertising on the



practice of law is yet to be determined and the effect of the U.S. Supreme Court's decision in Virginia Supreme Court v. Consumers Union of U.S., Inc. will be the subject matter of future decisions of the Courts.

I would urge all of the members of the Bar to participate more actively in The Florida Bar and the Broward Bar Association and to become more aware and concerned with the problems which must be dealt with by the Bar Associa-

### Guide for Non-Lawyer Personnel in Law Offices

In recent years more and more law firms have undertaken to utilize the services of non-lawyer personnel to assist the lawyer in preparation of legal documents and investigation of their clients' matters.

As the use of the non-lawyer personnel becomes more widely accepted and more common, the lawyer must guard against permitting the non-lawyer personnel to engage in the practice of law or to appear to engage in the practice of law.

The lawyer may employ non-lawyers to do any task for him except (1) counsel clients about legal matters, (2) appear in court or appear at proceedings which are part of the judicial process, or (3) otherwise engage in unauthorized practice of law; provided, however, the lawyer must become and remain responsible to the client for any work undertaken by the non-lawyer office personnel, supervise the work and maintain a direct relationship with the client.

When communicating with persons outside the law office, including other lawyers, a non-lawyer must disclose his status as such. The disclosure must be made in a way that avoids confusion. With respect to oral communications, disclosure must be made at the outset of the conversation. It is permissible for non-lawyer office personnel to sign letters on the firm stationery as long as the non-lawyer status is clearly indicated. A supervising attorney has the ultimate responsibility for compliance by the non-lawyer with the applicable provision of the code of professional responsibility.

Failure of an attorney to ensure that his non-lawyer personnel comply with the above limitations is a violation of Disciplinary Rule 3-104. However, in recognition of the increasing use and status of non-lawyer personnel in the legal profession, the Supreme Court changed Disciplinary Rule 2-102(A) and eliminated many of the restrictions placed on a lawyer or law firm in regard to professional cards, professional announcements, office signs, letterheads, telephone directory listings, Bar list, legal directory listings, and other professional notices and devices. The current rule provides that a lawyer may use any of the above enumerated items if they do not include a statement or claim that is false, fraudulent, misleading or deceptive, within the meaning of Disciplinary Rule 2-101(B) or that violates the regulations contained in Disciplinary Rule 2-101(C).

Based on the above change in the rule, it appears that Florida Ethics Opinion 77-28 which prohibited non-lawyer employees from placing their names on firm business cards may be outdated. Use of a business card by a lay employee, so long as the lay employee is clearly identified as a non-lawyer, appears to be permissible. In addition, the lay employee may also be identified on the stationery of the law firm, so long as the nonlawyer is clearly identified as a non-lawyer.

### High School Education Project

For the third consecutive year, the Young Lawyers Section has sponsored a High School Education Project. This project has received recognition for its excellence from both The Florida Bar and the American Bar Association.

The basic concept is simple: a lawyer speaks to a high school class and then answers questions. Topics for discussion are selected by the teacher, and the Young Lawyers Section matches an attorney (hopefully with expertise on the subject) with the teacher. The project is designed to be flexible and informal.

This year fifty-seven (57) attorneys have participated. Even though the school year is not over, twenty-eight (28) teachers at twenty-two (22) county high schools have availed themselves of the program. Young Lawyers Section also coordinates a mock trial program. The mock trial exposes students to the jury system by presenting a brief trial in which the student participate as witnesses and jurors.
