THE TEN ECONMANDMENTS

- 4. Maintain courteous and friendly relations with all of the employees of your clients with whom you have any communication.
- 5. Keep up with the times. Your optometrist, dentist, barber and physician are required to do so; so you are no exception.
- 6. A happy, satisfied client is like the root of a healthy tree and is, without a doubt, the source of your future success. "A" will recommend "B", who, in turn will recommend "C". An unhappy, dissatisfied client will not hesitate

to express his or her dissatisfaction with your handling of a matter to all of his friends — and to all of your partners.

- 7. Move active files through your office to a timely conclusion. Most law-suits do not improve with age, particularly if you are representing the plaintiff. A file needs attention; or as one immigrant said of the United States, "There is gold in the streets but you must learn to pick it up".
- 8. Maintain form files. When you have prepared all of the documents for a sale of a business; it is pure folly to not have them at hand for the next similar occasion.
- 9. Encourage, by performance, enduring relationships with your business clients. If he is comfortable with you, he will want to keep you. As he grows, so will you.
- 10. Constantly keep your eye on the bottom line. Continuing attention must be given to expenses and the necessity, or lack of necessity, for same; the collection of income, or lack of it; and the overall efficiency of the office and ways to improve it.




