

The reason for the establishment of the Broward Bar Foundation is to provide an entity to receive funds to accomplish special projects for the improvement of the administration of justice without the use of Association dues money. These projects have been handled informally in the past by the officers of the Association. Now we have a corporate entity, plus the assurance of tax deductibility, provided we continue to meet Internal Revenue guidelines.

The first project of the Foundation is the Criminal Division Judge's Luncheon Conferences. The Foundation has underwritten the cost of these conferences which have been held monthly since August. The Conferences were extended to provide a Civil Division Judge's Luncheon Conference starting in December. Individual lawyer and law firm contributions to the Foundation have covered the cost. Chief Judge Weissing has told me and others on several occasions that these conferences are most helpful in facilitating communication between the judges. The Broward Bar Foundation will be exploring other sources of funds and other projects. Suggested sources of funds include membership contributions, memorial gifts, special purpose contributions and grants from other organizations. Suggested projects include funding a pro bono project, new Bar Association building, scholarships and loans for law stu-

# Administrative Order No. 2.01.5

(As amended December 10, 1981)

#### IN RE: Non-Courthouse Hearings In Uncontested and Ex Parte Matters

- 1. All uncontested Circuit Court Civil matters and ex parte matters, including final hearings and trials, may, subject to the limitations hereinafter contained, be heard at any Satellite or Regional Courthouse facility now or hereafter established and designated by Rule of Law.
- 2. Parties bringing uncontested matters on for hearing may notice them at any Satellite or Regional Courthouse facility provided that the offices of all opposing counsel are within the geographical limits of the area to be served by that particular facility, or if agreed to by all parties and the Court.

- 3. Notice requirements are the same as in all cases except that a party giving notice of hearing at any Satellite or Regional Courthouse facility shall specify the location of the hearing with particularity by giving location and address thereof.
- 4. The Honorable Morton L. Abram. Robert L. Andrews, George A. Brescher, J. Bart Budetti, Patti L. Englander, Harvey Ford, William Herring, Brian P. Kay, John T. Luzzo, Ross E. Mowry, Constance R. Nutaro, Dale Ross, Larry Seidlin, Steven Shutter, and Alfred Skaf, County Court Judges, are assigned to temporary duty in the Circuit Court to handle all matters which may come beorder, from this date until further Order of the Court having all the power order of the Courtfi having all the power and jurisdiction of Circuit Judges of the Seventeenth Judicial Circuit. A copy of this order shall be placed in the court file of each case heard by each of said

judges and motions for rehearing on such matters shall be brought before him or her.

- 5. Appointments for uncontested and ex-parte matters under this order shall be made with the secretary of Judge Abram in the South Regional Courthouse and the secretary of Judge Ford in the North Satellite Courthouse.
- 6. Hearings under this order shall be scheduled in the South Regional Courthouse on Tuesday afternoons, and in the North Satellite Courthouse on Friday afternoons.
- 7. The geographical limits of the area to be served by the Pompano Beach facility is that bounded on the north by the Broward-Palm Beach County line and on the south by Commercial Boulevard.
- 8. The geographical limits of the area to be served by the South Broward facility is that bounded on the north by Sheridan Street and on the south by the Dade-Broward line.
- 9. The requirement that all final hearings or trials be set only upon order of the court remains in effect, and the attorney presenting a motion or stipulation together with a proposed order setting a case for final hearing on trial shall request the Clerk to forward such documents and the case file to the appropriate County Court Judge for his consideration and entry.

## Probate Division Courts Committee Report

As a result of strong cooperation and assistance from Robert Lockwood, Clerk of the Circuit Court, a one hour seminar is being conducted each week by Jim April for the benefit of the middle and senior clerk of the Probate Court in an effort to assist them in rendering service to the Bar and the public.

Recent budget cuts have delayed the concentrated efforts to obtain additional personnel for the Probate Clerk's Office and also to obtain thoroughly experienced paralegals for each of the Probate Judges who would function in a manner similar to the Dade County, "Ex-parte Clerks". The Committee intends to pursue this matter and eventually obtain a greater allocation of funds for the Probate Clerk's Office.

Because of shortage of funds and resulting shortage of personnel, it is necessary that the Probate Clerk's Office will be only open to the public and the Bar from 9:00 A.M. to 4:00 P.M. The new hours will involve no service at the counters or by telephone except between the stated hours. Pleadings that must be dropped off at the Clerk's Office after 4:00 P.M. can be dropped in a box in Room 259 of the Central Courthouse only. It is to be noted that pleadings received in the drop box will not be clocked or received at that time.


