PRESIDENT'S MESSAGE

I am happy to report to you that the combined efforts of the Bench and Bar have accomplished considerable advances in the past six months. Our Circuit Court is functioning at more efficient levels than at any time in recent years. Some factors which have contributed include:

- 1. Judges have been assigned to divisions where their experience is most effective in moving cases.
- 2. Several divisions instituted case management procedures which have increased the number of case dispositions and reduced continuances.
- 3. The civil pilot program featuring a uniform motion practice commenced August 31 with 4 divisions. As of January 1 we will have 12 civil divisions participating.
- 4. Civil and criminal divisions communications among Judges have been improved by Bar sponsored monthly luncheons.
- 5. The Court is asking for and receiving help from outside consultants.
- 6. Our retired Judges continue to do yeoman work in trying our overflow of

Yet all of this is not enough to solve the congestion clogging our dockets.

Just as we reached full Judicial

strength for the first time early in December, the ranks were thinned by the death of Judge King and the health problems of others.

Despite all these efforts resulting in increased dispositions the increased case filings exceeded the ability of the system to cope with them. The result is an increase in pending cases over the past four years amounting to over 91%.

The solution remaining is more Judges. Accordingly, Chief Judge Weissing asked and your association has approved a request for fifteen additional Circuit Judges, ten in the Circuit Court and five in the County Court.

This request is currently under consideration by the Supreme Court. Even if additional Judges are certified, the extremely tight fiscal situation in state government will make legislative adoption difficult.

The Circuit Court of the county needs your help now!

> First, to continue your support of the programs to improve case dispositions, and second, to support our Chief Judge's reguest for additional Judges.

You can help by contacting the Court and your State Legislature. Let them know you support the additional Judges for Broward County.

COMMITTEE REPORTS

Trust Law

The Trust Law Committee of The Florida Bar Real Property, Probate and Trust Law Section is undertaking a review of the Florida trust statutes to determine the need for statutory clarification or codification of case law not now appearing in the statutes.

Administration Committee

The Administration Committee of the Broward County Bar Association has met on a regular monthly basis since its detailed Phase I Report, wherein it advised the Executive Committee of its findings upon review of the DuRant Report, and reported to the Committee the status of completion of each of DuRant's suggestions.

Phase II has consisted of a thorough examination of these suggestions and a segregation into three "priority areas" for further review and eventual recommendation to the Executive Committee. The three priority areas with accompanying responsibilities which the Administration Committee is now reviewing in detail are as follows:

- Office Administration—John Hume: to include a review of the internal workings and procedure of the Bar office itself.
- Public Relations Terry Russell: to include a review of public relations with the general public, and separately, a review of the Bar's relations with its members themselves.
- 3. Financial Bill Davell: to include a review of the Bar's financial struc-

PRESIDENT'S MESSAGE MANDATORY PRO BONO

As the New Year begins, I think that it is appropriate to look back at last year. In my opinion, the single most important issue confronting Young Lawyers in 1981 was mandatory pro bono. The explanation is simple.

In the first instance, over half of the attorneys practicing law in this state are Young Lawyers. Further, if mandatory pro bono is instituted, obviously the Young Lawyers in each of the law firms are going to bear the responsibility of handling these cases. Therefore, every Young Lawyer has a significant stake in the resolution over the mandatory pro bono debate.

Although it is easy to argue the merits of mandatory pro bono, I think that it should be clear to every lawyer that mandatory pro bono is going to be a reality. The proposal presented recently to the Board of Governors of the Florida Bar tying pro bono to both local and statewide lawyer referral systems is unacceptable. Clearly, the access of the public through the lawyer referral system should not be abridged by mandatory pro bono. More importantly, the lawyers participating in such lawyer referral program should not be the only ones to bear the pro bono workload.

An answer must be found which serves to provide legal services to those who cannot afford it through a system which fairly apportions the pro bono cases. Since the Supreme Court has indicated that it will require every practicing lawyer to take pro bono cases if a solution is not found, I think that every Young Lawyer has a vested interest in participating in the decision-making process which resolves this difficult issue.

CIRCUIT COURT, CIVIL DIVISION PROCEDURES

The Judges of the Circuit Court, Civil Division met at 5:00 P.M. on November 24, 1981, discussed and approved the following procedures:

- A. That all judges, after spirited debate and unanimous vote, would sign all pleadings and orders in black ink.
- B. That the Clerk shall be directed, upon administrative order from the Chief Judge, that all defaults may be obtained on the 21st day following the service of process.
- C. That it be recommended that the

Chief Judge, by administrative order or memorandum, should advise the Clerk that it will not be required at anytime that a Non Military Affidavit be filed prior to default.

- D. That the Chief Judge, by administrative order or local court rule, shall direct that the Clerk shall not issue more than one Summons upon a defendant, other than by court order.
- E. That the Chief Judge, by administrative order or local rule, shall direct the Clerk not to issue more than one execution upon a Defendant other than by court order unless the original execution is returned to the Clerk,
- F. It was agreed among the members at the meeting, with regard to Spouse Abuse cases, that the Clerk or Judge shall not accept any Counterclaim for Dissolution of Marriage or Amendment For Dissolution of Mar-

riage on a case initially filed as a Spouse Abuse matter pursuant to F.S. 409.602.

In addition, it was agreed that the courts cannot order abusive spouses out of their homes under the Spouse Abuse Statute.

In addition, the civil court judges should review a copy of the Statute, along with a copy of the form petition and form order presently in use by the Clerk to determine some method whereby the order may become final after a specific period of time, so that the Clerk may consider it to be a Final Order and close the file.

G. It was approved unanimously that the secretaries may require of attorneys noticing a case for trial to provide the secretary with stamped, self-addressed envelopes for the mailing of the Order Setting Trial. This applies in both jury and non-jury cases.
