

# FOR LAWYERS TOPIC OF NEW ABA PUBLICATION

A new publication from the American Bar Association Economics of Law Practice Section outlines a complete accounting system designed especially for the small law firm.

"Simplified Accounting Systems and Concepts for Lawyers" stresses the necessity of a sound accounting system to minimize the business risks involved in operating small firms.

The publication describes the serious problems caused by uncoordinated and nonuniform bookkeeping; explains bookkeeping principles to those with little experience in systemizing financial records; and provides a standard chart of accounts incorporating standard accounting titles and a uniform numbering system.

The 145-page paperbound book includes chapters on Basic Bookkeeping for Lawyers, Cash Disbursements and Payroll, Client Billings and Rebillings, Client Trust Funds, and Profit Planning and Budgeting.

"Simplified Accounting Systems and Concepts for Lawyers" utilizes humorous examples to illustrate basic accounting principles and also contains numerous charts, graphs and illustrations to demystify the accounting process for the inexperienced attorney.

## RESOLUTION TO ENDORSE THE GENERAL MASTER PROGRAM

WHEREAS, the General Masters' Program has been successfully operating for over five years in Broward County under the supervision of the Chief Judge and subject to the adoption of Reports by the Circuit Court Judges.

WHEREAS, the Broward County Judges are experiencing a backlog of over thirty-two thousand cases. The General Masters are expected to relieve the Circuit Court Judges of over ten thousand hearings in 1982 in the areas of probate, support enforcement and domestic relations.

WHEREAS, it is recognized that the General Masters, each being a qualified attorney, have exhibited, through dedication and hard work, a professional approach to this pressing

WHEREAS, the Supreme Court has not certified and the legislature has not approved the recommended number of judges to adequately dispose of the growing volume of cases in Broward County, Florida.

WHEREAS, the Supreme Court has organized a Matrimonial Law Commission to study and evaluate the pro-

- 1. 


