# FEE ARBITRATION

The Fee Arbritration Committee of Broward County Bar Association has been operating since 1978. The Committee has jurisdiction over any disagreement concerning fees paid, charged or claimed for legal services rendered by an attorney licensed to practice in the State of Florida and having an office within Broward County. The parties to such disagreement must agree to arbitration, either by prior written agreement or by the filing of a request for arbitration signed by such parties. There is also an administrative fee of \$20 which must be paid by both parties.

There are approximately twenty-five cases filed each year. The members of the Committee have given a great deal of their time and effort in hearing the matters presented to them and should be commended by the entire Bar for this effort and the good public relations that the Bar receives as a result of this contribution.

# LAWYER REFERRAL SERVICE COMMITTEE

Approximately two hundred sixty (260) attorneys were registered for the Lawyer Referral Service Panel for the year June 1, 1981-May 31, 1982, and approximately 3250 referrals were made. Major area of referral were domestic relations, criminal, estates, labor, negligence and real estate matters.

Through August 20, 1982, two hundred thirty two (232) lawyers have joined the Panel. The service is a means through which the Legal Profession can render better service to the public and provides a method whereby any person who can afford to pay a reasonable fee for legal advice, and who does not have a lawyer, may be referred to a lawyer willing to give a brief consultation for a fixed fee. Where necessary, additional legal service will be provided for a reasonable fee to be agreed upon between the lawyer and client.

Effective June 1, 1982, a special panel has been implemented called PRO BONO LAWYERS FOR THE ARTS PROGRAM. Qualified artists and non-profit arts organization may be referred to attorneys who have special expertise in handling legal problems related to the arts.
