

Linda Conghan Receives The Florida Bar President's Pro Bono Service Award

The Florida Bar President's Pro Bono Service Award is presented to attorneys for their voluntary commitments in making free legal services available to the poor in this state.

Linda Conahan was presented this award for her dedicated efforts in establishing the "Broward Lawyers Care" program — the Broward County Bar Association's Project for involving both private attorneys and legal services lawyers in pro bono representation. She served as Chairperson of the Broward Bar's Pro Bono Coordinating Committee tasked with the responsibility for the program, and was the main driving force for its implementation last May. As a viable entity, that program has referred over 230 legal aid cases to approximately 170 volunteer lawyers.

ATTORNEYS AS EXPERT WITNESSES — FEES TAXABLE AS COSTS

Murphy v Tallardy, 422 So.2d 1098 (4 D.C.A., 1982)

By: County Judge Steven G. Shutter A recent unheralded decision of the Fourth District Court of Appeal will have an important effect on attorneys. In *Murphy* v. *Tallardy*, 422 So.2d 1098 (4th D.C.A., 1982) the Court held that when an attorney is called as an expert witness as to the value of the reasonable attorney's fee due the principal attorney in the case in chief, the testifying expert attorney shall be awarded an expert witness fee taxable in the nature of costs. For many years expert witnesses such as doctor, accountants, economists, engineers as well as plumbers and automobile mechanics were routinely award-



SPECIAL MOTION CALENDAR FOR TEMPORARY PRETRIAL RELIEF IN DISSOLUTION CASES

Effective March 25, 1983, and each Friday thereafter, the undersigned judge will hear applications for temporary pretrial relief in domestic matters from 11:00 A.M. to 12:00 noon on FRIDAYS. The following provisions apply:

- 1. Financial affidavits are required.
- 2. Cases are limited to 10 minutes.
- Counsel shall not make appointments with judge's judicial assistant but shall notice the opposing party in accordance with applicable statutes and Rules of Procedure.
- 4. A copy of the Notice of Hearing, Motion and Financial Affidavit shall be in the hands of the judge's assistant (not just the clerk) four (4) working days in advance of the hearing. This requirement may be relaxed if adequate notice is given to the opposing party and if the moving party hand-carries the file to the courtroom.
- 5. Contempt and Post Trial matters will not be heard on this calendar and may be referred to the General Master.
- 6. Effective March 18, 1983, no motions for pretrial relief will be referred to the General Master.

JUDICIAL INSIGHTS

Waitress, cook, textile lab specialist, attorney, judge; through these many and varied occupations, Linda Leslie Vitale continued to maintain a singular purpose — to work as hard as she could to do the best job possible. More than any other asset, this strong sense of determination is responsible for her success today.

An only child, Linda Vitale was born in Reading, Pennsylvania where she remained until college. She attended college at the University of Delaware, earning a Bachelor of Science Degree with Dean's List honors in business administration and economics. Linda moved to South Florida where she was accepted at the University of Miami Law School. There she met her future husband, Louis Vitale and was married in 1968. Her energy and drive prompted her to study evenings toward an LLM in taxation at the Univ. of Miami Law School. After law school, she began to build a general practice on her own

and later joined forces with her husband as law partners in "Vitale and Vitale". In 1975, she left Florida to work for the Internal Revenue Service in Washington, D.C. While excited by the energy of the Capitol, she soon tired of working with dry tax formulas and yearned for greater involvement with people.

Linda left Washington D.C. and returned to Florida where she concentrated her efforts on building a general civil practice. She now looks back on those formative years as important in preparing for civil practice on the Bench. Her willingness to work hard was soon rewarded with an appointment as General Master in January, 1978. During the ensuing three years, Linda learned how rewarding a position on the Bench could be. Foreseeing stiff competition in the upcoming judicial election, she aimed at earning an available Circuit Court position. After much hard compaigning and the help of her then ex-husband (Louis Vitale and fiance Don Ruf), she did win and took office in January, 1981.

Now married to Don Ruf, a teacher at a private school, Judge Vitale finds time restraints the most serious challenge to her personal life. She relishes the quiet time spent at home with her husband and enjoys camping and boating. However, it is no secret that behind those quiet girlish locks is a judge with a willingness to work hard and an iron-clad determination to succeed.

Looking back at the past two years on the Bench, Judge Vitale considers the pressure of making immediate decisions as the most difficult task of being a Judge. The greatest reward, on the other hand, is "working closely with the community in solving its problems." Some hints to young lawyers practicing in front of Judge Vitale: she does not favor aggressive advocacy and considers sarcasm toward opposing counsel as a sign of discourtesy to the Bench. To do well with Judge Vitale presiding, one should be "... well prepared, courteous, and don't expect any continuances ...!"

Aid Clinic \$ 6,750.00


These grants are a part of the second round of IOTA grants for legal services to the poor. Thirty one agencies received grants totalling \$288,000.00 in the second round of grants.

totalled One Million Dollars. A total of 2430 lawyers in Florida and 233 in the 17th Judicial Circuit now participate in IOTA.

IOTA grants will go to an annual cycle commencing in September 1983. Foundation officials anticipate that an additional \$750,000.00 will be available for distribution to legal aid organizations at that time.

JOINT MEDICAL LEGAL COMMITTEE RECONSTITUTED

The presidents of the Broward County Medical Association and the Broward County Bar Association have recreated a joint committee of members of the two associations to address issues of concern common to the two professions. Appointed from the Medical Association were Dr. Paul Flaten, Dr. Donald Comiter, Dr. Rolando Jorge, Dr. Donald Giulianti, Dr. Wylie Scott and Dr. Gary Torian; representing Broward's lawyers are O. Edgar Williams, Jr., Maurice Fixel, Donald G. Korman, Judge Henry Latimer, John S. Neely, Jr., Wilton L. Strickland and Rex Conrad.

A similar committee was active during the 1960's and 70's but was disbanded when anti-trust rulings threatented its primary activity of establishing recommended fees between the professions and mediating disputes over such charges.

The new committee still hopes to assist the medical and legal professions in such matters but will not attempt to set charges or fees. Rather, it hopes to effect conciliation of disagreements by lending its counsel and guidance, and will strive to prevent disputes from occurring by educating each profession to the problems and needs of the other and by providing a forum for the exchange of views and recommendations.

The committee, which held its organizational meeting on February 22nd, will meet monthly at the Medical Association's offices. Members of either association having matters which they wish to submit to the joint committee should contact Bill Stafford of the Medical Association or Norma Howard of the Broward County Bar,

ed compensation, taxable as costs to the prevailing party, for their time and expertise in preparing for and testifying at trial. However, attorneys have been discriminated against. The law is well settled that to prove the value of reasonable attorneys fees a live expert witness attorney must testify at trial (absent stipulation of the parties). See Lamar v Lamar, 323 So.2d 43 (4th D.C.A. 1975). It has been tacitly assumed by the Bench that an attorney called as an expert witness was doing the principal attorney a "favor" and should not be compensated for an hour of two of his time. The Murphy decision has placed the attorney on an equal footing with all experts.

Although the decision was rendered in a Dissolution of Marriage proceeding, it applies to any matter in which the Court must make a factual determination as to the amount of reasonable attorney's fees. The decision will have several important effects.

First, the obvious benefit will be that attorneys will be compensated for their expert testimony.

Second, in many cases where attorneys acting as experts have been charging for their time and expertise now, the losing party instead of the prevailing party will pay these costs as it does with all other taxable costs.

Third, in many matters it will encourage all sides either to agree to a fair attorney's fee by stipulation or to at least agree to a determination of the amount of attorney's fee to be made by affidavit. This will free at least three attorneys for more productive matters as well as saving Judicial time.
