#### JUDGE JOHN G. FERRIS, NEW CIRCUIT CHIEF JUDGE



Judge John G. Ferris

The Honorable John G. Ferris took office as the new Chief Judge of the Seventeenth Judicial Circuit Court of Broward County effective July 1983. However, the use of the phrase "new" is not totally accurate, as Judge Ferris was elected as the first Chief Circuit Judge in 1973 immediately after the Judicial Reform Constitutional

Amendment had taken effect to eliminate Municipal Courts and Courts of Record and replace them with the existing system of Circuit and County Courts. In 1973, Judge Ferris was aware of the animosity that had arisen between various sections of the Court, in that various factions of the Court of Record, Probate and Juvenile Divisions had fought the Article V Reform. Judge Ferris ran for election as Chief Judge at that time as he felt that he could help heal the schism between the Judges.

In 1983 Judge Ferris ran again for seat of Chief Judge at the request of other concerned Judges. Judge Ferris feels that it is the duty of all the Judges to assist in the administration of the Judicial system, although it has been his experience that just a few people appear over and over again in the administrative job.

THE POSITION: Although Judge Ferris has had previous experience as Chief Judge, the responsibilities of the position has seen a great deal of change since 1973. During the Judge's initial service between 1973 and 1975, he had carried a fairly full case load in addition to the administrative duties. The duties of the Chief Judge now

are so extensive that it is very difficult for the Chief Judge to carry a case docket. Judge Ferris indicated that he would not be carrying a regular case docket, but would like to continue to sit on cases and help if one of the other judges were in a "jam", as his time priorities may allow.

The Chief Judge has the responsibility of responding to the needs and desires of 58 Judges and 58 Judicial Assistants. In addition to the Judges and Judicial Assistants, there are approximately 125 support people in the various program which fall under the administrative supervision of the Chief Judge. These programs include the Mediation Program which has been successful in helping dissolution parties to come to agreements regarding custody and support disputes; the Citizen's Dispute Program which handles neighborhood disputes in an effort to resolve these matters amicably and without the need for full Court pro-ceedings; and the Witness Liaison Program which helps coordinate the availability of witnesses for criminal cases in an effort to minimize the time the witnesses have to spend in

## FLORIDA LEGAL CREDIT UNION

The Florida Legal Credit Union is a savings and loan association organized under state law. Sponsored by Attorneys' Title Insurance Fund, Orlando, and the Orange County Bar Association, the credit union has grown steadily since its inception in October 1979.

ALL Florida Bar members AND their employees (except employees of the State of Florida) are eligible to join the credit union. An initial deposit of \$5.00 along with a membership fee of \$1.00 makes one a member. And, once a member, always a member, with full membership rights.

Recently, the credit union started paying daily interest on savings at the rate of 7%, with interest paid on the last day of the calendar quarter. ALL accounts are insured up to \$100,000 by the Florida Credit Union Guaranty Corporation, an agency of the State of Florida.

There is a 90 day membership requirement before a member may make application for a loan. The unsecured loan maximum is currently set at \$1,000 with a repayment period of 18 months and annual percentage rate of 14%. And, if the borrower qualifies,

Former Broward Circuit Judge Henry Latimer, who resigned from the bench in March to reenter private practice, has become resident partner of his firm's new Fort Lauderdale office at 2300 E. Las Olas Blvd.

Other programs under the supervision of the Chief Administrative Judge are the Guardian Ad Litem Program in the Juvenile Division; the County Probation Department in handling misdemeanor matters; and the General Master's Program which handles all Baker Act matters and assists in dissolution proceedings.

Judicial Branch is a totally separate unit of County Government and is responsible for managing its separate unitary budget in excess of \$7,000,-000.00, not including judicial and secretaries salaries, which are paid through the state. The Chief Administrative Judge oversees the Court Administrator's Office which handles the budget and which is also responsible for coordinating the schedules of the Judges, Courtrooms, vacations, etc. Finally, the Chief Administrative Judge serves as a liaison to promote good relations between all of the Circuit Judges and also as the liaison between Broward County Judges and the Chief Justice of the State of Florida.

In assuming the position as the Chief Administrative Judge, Judge Ferris is aware that there are many issues which will need to be dealt with. One of the items which he feels is most important, and which he intends to promote, is the obtaining of financing to allow the Courthouse to acquire its own computer system. Currently, the Judicial Branch is one of many County organizations which are part of a computer user group for a computer which is housed on the tenth floor of the Courthouse. Judge Ferris believes that the Court Administrator is currently hindered by a great deal "down-time" on the computer, while the system is being used by other County offices. If a separate computer were obtained to be used solely by the Judicial Branch, it is hoped that this would help to make the Court system more efficient in many ways.

THE LAWYER AND JUDGE: The realization by Judge Ferris that it is time for the Judicial System to consider effective usage of computer technology reflects the numerous changes which have taken place since the Judge first came to Broward County in 1957. Judge Ferris remembers the City of Miramar when "there were more cows than people."

John Ferris was born in Detroit, Michigan in 1922. He was raised by his Romanian parents under the Eastern Orthodox Catholic faith and his philosophy still reflects that upbringing.

After serving four years in the United States Navy, Judge Ferris attended the University of Detroit Law School where he received his LLB Degree in 1948. He then practiced as a member of the firm of Ferris and Warren until moving to Florida. It was actually cold weather which brought Judge Ferris to Florida, as he received doctors advice to get away from the cold weather to help minimize heart trouble.

The Judge worked as a claims supervisor for Allstate Insurance Company from 1957 to 1958. During that time, he handled all types of claims, including automobile, landlord liability and fidelity bonds, which gave him a broad experience to later assist him on the bench.

John Ferris was admitted to The Florida Bar in 1958 and appointed as a Municipal Judge in the City of Miramar immediately thereafter and served in that capacity until 1963. During that same time period Judge Ferris also served as Assistant and then Chief-Assistant Solicitor (Prosecutor) of Broward County, and was also very active in the City of Miramar as an elected Councilman, a member of the Airport Zoning Board, and Chairman of the United Fund in Miramar.

In 1963, John Ferris was appointed by the Governor to the Court of Record of Broward County. At that time the Court of Record had jurisdiction over criminal matters ranging from traffic infractions to murder cases and civil jurisdiction of claims up to \$10,000.00. The Article V Reform took effect in 1972, creating the Circuit Court Bench and Judge Ferris was elected as a Circuit Court Judge, a position in which he has served since July, 1972.

During his services as a Court of Record Judge. Judge Ferris has served in many capacities including the Elected Presiding Judge of the Court of Record of Broward County in 1971-1972. Additionally, he served on many state and local committees, as well as participating in Law Enforcement and Judges Conferences throughout the United States.

THE MAN: Judge Ferris has three daughters, Janet, Julie and Susie. Janet has followed her father into the legal

profession and has been practicing as an attorney for five years.

An interesting aspect of Judge Ferris' personality and interests is evident immediately upon entering his chambers. Along one wall are numerous pictures of movie-stars, including some pictures with the Judge. Judge Ferris initially developed an interest in motion pictures as a young boy while his father owned a theater. In 1974 Judge Ferris developed a friendship with Dustin Hoffman while the Judge was acting as Technical Advisor to Director, Bob Fossey on the film. "Lenny" which was filmed in the Broward County Courthouse. The Judge also has a picture of Liza Minelli, who was a visitor during that filming.

The Judge pointed out that the Courthouse has been used as a filming location on several occasions: several years ago for filming some commercials with Mickey Rooney and, in the past several months, the Broward Courthouse parking lot was used for shots in Paul Newman's new film, "Harry and Son". Judge Ferris is in favor of encouraging the growth of the movie industry in South Florida. He feels that this is a natural industry for Broward County as the weather allows for good clarity of filming and the movie industry would bring new money and jobs into the area and is a natural to go along with the tourist industry that already exists.

One of the better known cases which the Judge has decided was the case of Satz v. Perlmutter, 362 So.2nd 160 (4DCA 1978), which dealt with an individual's right to discontinue artificial life support systems. Judge Ferris stated that his decision in that case received reaction from all over the world, including lay people from London, Paris and Rome. He indicated that he was pleased to receive feedback on a case, which is unusual, but was especially pleased that 98% of the reaction was extremely favorable.

In settling into his new position as Chief Judge, Judge Ferris commented favorably on the other Broward County Judges: "I think they are great. There is a good blend of young and old judges." The Judge pointed out that he believed the Broward Bar generally could do more to support members of the Bench and, particularly, he felt that the Bar should make every effort, if possible, to stand behind a Judge that might be having some difficulty with the media.

Judge John G. Ferris, Chief of the 17th Judicial Circuit, is recuperating from open heart surgery performed on Monday, August 1, 1983.

### LOW COST CRIMINAL LAWYER REFERRAL SERVICE PROGRAM

To the people who know me, it may seem quite incongruous that I am chairing a committee of the Broward County Bar which is developing a Low-Cost Criminal Lawyer Referral Service Program. To those who don't know me, the fact that I never set foot out of the civil sphere of the practice would explain my first comment. In any event, as a result of being fortunate enough to chair the Lawyer Referral Service Committee, which is in charge of this program, I am learning more about the criminal sphere of practice than I have learned since my criminal law and criminal procedure courses many, many years ago.

The purpose of the program is for the Bar to provide a vehicle to those criminal defendants who cannot quali-

In order to qualify for the program, the defendant will not be able to have gross earnings of more than \$375.00 per week or liquid assets of more than \$1,000.00, depending upon the number of dependents and the severity of the crime with which he is charged. Additionally, consideration will be given to the assets owned by the defendent, both real and personal in nature, so that a determination can be made as to whether the individual will qualify for the program.

The program will be unique, in that it will be up to the Judge before whom the defendant appears to make the determination as to whether each defendant would qualify for the program, and only in that case would that defendant be scheduled for an appointment with those attorneys who have signed up with the program through the Broward Bar Office. Defendants would not, on their own, be able to make arrangements to be represented by the attorneys who have registered for the program, which in some respects would limit the number of defendants we anticipate being serviced by our program.

The program will work very much like the present Lawyer Referral Service, in that the appointments will be made by the Broward Bar staff after the defendant has been referred by the Judge. At no time will the criminal defendant make the initial appointment directly with the attorney, nor will the defendant be able to qualify himself for the program by contacting the Broward Bar Office and seeking an attorney to represent him.

The members of the Bar who register for this program will be doing a great service to the members of the community, as well as providing the much needed assistance which the Public Defender's Office presently requires. Unfortunately, without the availability of this program, several of the people who might not otherwise qualify for a public defender seem to be sifting through into the Public Defender's Program because of their virtual inability to obtain private counsel to represent them.

This article is being written primarily to encourage those members of the Bar who practice in the criminal defense sphere to sign up for this program with the Broward County Bar. Information in connection with maximum fees allowable to be charged under the program and all other questions in connection with the program may be directed to the Broward County Bar Office.

We are hoping that the response by the criminal defense attorneys in our area will give this program the support it needs in order to function properly. We are hopeful that the program can be commenced immediately after Labor Day, which would require your immediate response to our quest for support.

This program will give the lawyers of our community another opportunity to demonstrate our concern and involvement in our community. We look forward to your support and cooperation in making this program a success.
