
SCHOLARSHIP FUND **ESTABLISHED**





HISTORICAL BACKGROUND - STRANAHAN HOUSE, INC.

In South Florida it is rare when one historic site and structure retains its essential character for three-quarters of a century

The Stranahan House, which has stood at the center of Fort Lauder-dale's growth since the early 1900's played a central role in the economic and social life of the frontier settlement

In the early 1890's that portion of the southeast coast of Florida between Lake Worth and Biscayne Bay was virtually uninhabited. In 1892, Dade County built a road from Lantana to Lemon City (now North Miami). An overnight camp on the New River was opened and young Ohioan Frank Stranahan was hired to take charge of the operation.

The Seminole Indians soon became his friends and trading partners. It was not long before the New River Camp became a well known retreat for wealthy sportsmen. Famous visitors to the camp included Admiral George Dewey and Henry M. Flagler whose Florida East Coast Railway would arrive at the New River in 1896.

As his business prospered additional room was needed, so a covered porch was added to the western and southern faces of the building fronting the river

Stranahan's brother Will had joined him and assisted in the transactions with the Indians. They brought in items such as otter pelts, egret plumes and alligator hides, the latter two of which were valuable to the international fashion industry of that day.

A hurricane in1895 destroyed most of the camp, which was rebuilt with mostly permanent structures. The store was expanded again with the addition of an east wing and porch. The white sand road leading to the water's edge is today the location of U.S. Highway 1 and the New River Tunnel.

By the late 1890's, Stranahan's trade with the Seminoles was at its zenith, and winter visitors continued to frequent the tourist camp. At age 35, Frank Stranahan was a well established and successful businessman in a rapidly growing community.

By 1899 several families with children had settled at New River, and the Dade County School Board agreed to send a teacher if the community would provide a school. The teacher assigned

was 19 year old Ivy Julia Cromartie.

The Post Master, Frank Stranahan, was captivated by the young school teacher and romance ensued. They were married at the bride's home in Lemon City on August 16, 1900.

When the couple returned to New River they took up residence in a cottage near the store and Mrs. Stranahan soon began to befriend and teach the Seminole youngsters who accompanied their parents on trading visits to the store. This was the beginning of her life-long service to the Indian people

In 1901, Stranahan began construction of his store which would ultimately become the family home as well. It was a classic Florida frontier design: a stark 24 by 32 rectangle with high ceilings and narrow windows, constructed of Dade County pine which was extremely durable and impervious to termites. The broad verandas which gave the structure its elegant appearance, were also functional in that they provided a sleeping area for the Indians who traded at the store located on the bottom floor. The upper floor, originally reached only by an outside staircase, was used as a public hall where weekly dances and other festivities were held. The Stranahans did not occupy the structure as a home until 1906.

By that time the newly organized firm of STRANAHAN & CO. had moved into its new building on North River Drive and Brickell Avenue.

Frank Stranahan's major interests were in banking and real estate. In

1911 he organized the Fort Lauderdale State Bank and served as its president.

Another profitable venture was the Stranahan Building Company which engaged in a variety of development projects. Stranahan was active in the political life of the community, serving almost continuously as a member of the City Council.

The imposing house on the river was a barometer of the Stranahan's growing affluence. Major renovations were undertaken and the facade was enhanced by the addition of bay windows. Electric wiring and modern plumbing capped an extensive capital outlay. The home still received its primary water supply from a windmill-powered pump and tank storage system.

Stranahan House had become a Fort Fort Lauderdale landmark by the late teens, and was used as the location for at least one silent movie made in the area. It also appeared on a number of post cards.

The Roaring Twenties brought yet another transformation in the house. An enclosed screen porch with gaily striped awnings was added to the front, and the entrances were changed to the east and west sides. This worked the final reorientation of the home away from a river approach which had been its dominant feature since the trading days.

The collapse of the "Land Boom" in 1928 took its toll of Mr. Stranahan's

health and fortune. While all of his business interests suffered, the crushing blow was the failure of the Fort Lauderdale Bank.

Despondent over his poor health and the financial ruin of friends for which he felt responsible, Frank Stranahan, at age 65, took his own life by plunging into the New River.

Mrs. Stranahan was able to save the home and some real estate; nevertheless, she was in dire financial straits during the depression years. As a result, the house once again reverted to commercial use.

The ground floor was leased as a tea room and restaurant called the

WATERS EDGE INN.

To generate additional income, she sometimes moved into the attic and rented the rooms on the second floor to winter tourists.

In 1939 the E.J. Blackwells leased the home and opened the Pioneer House Restaurant. During the next four decades a series of additions almost obscured the original house.

By the late 1960's the Pioneer House was well off the beaten path, hemmed in by the tunnel ventilators and commercial development along Las Olas Blvd. and profits began to decline. The property suffered from lack of maintenance and proper upkeep, and the restaurant closed permanently in 1979.

During the 1960's there was a resurgence of public interest in the Stranahans. The Stranahan House was formally added to the National Register of Historic Places in 1973.

In 1968 Drake College awarded Mrs. Stranahan the honorary Degree Doctor of Humanities and Florida Governor Claude Kirk proclaimed a "Mrs. Frank Stranahan Day."

On August 30, 1971, Ivy Julia Cromartie Stranahan passed away at age 90.

Today the Stranahan House stands in the midst of a great city, a visible link with its colorful past, but time is running out on this Grand Old Lady of the river. The ravages of time and the South Florida climate have made restoration imperative.

Stranahan House, Inc. has taken steps to preserve the structure, but the lengthy and expensive undertaking calls for total community involvement. Public officials, civic leaders, and ev-

eryday citizens must rally to its support if future generations are to know and enjoy this significant segment of Broward County and South Florida's heritage.

FEDERAL ADMISSIONS EXPERIMENTS: FROM COURTROOM TO COUCH

These days a slip-up in federal court could mean a mandatory trip to a psychiatrist's couch-for the lawyer, not the client. As part of an experimental program to improve lawyer competency in fourteen federal district court, attorneys in some districts could be forced to seek psychiatric help. The program grew out of a 1979 survey by a committee of the Judicial Conference of the United States. The committee found evidence that some lawyers practicing in federal courts were not competent, and proposed tightening admission procedures for federal court practice. Attorneys would have to take a special bar exam, and prove that they had four supervised trial experiences before they could litigate federal cases. Continuing legal education and peer review of trial performance would also be mandated.

These remedial requirements have "dubious necessity and doubtful legality," writes Joan Hall in the current issue of Litigation, a quarterly published by the ABA Litigation Section, which she chairs. Hall finds the peer review requirements "distasteful." Under the programs, lawyers who receive peer review complaints would have to submit to counselling by a professional assistance committee. In some districts they would even be forced to see a psychiatrist. "In a free society," she writes, "a decision to seek treatment must be private." The procedures are unfair, she says, because attorneys will never know who filed the complaint complaints are strictly anonymous. Even lawyers should have a right to face their accusers, Hall maintains.

Hall believes the experimental programs may be "a threat to the independence of the bar." She urges attorneys in the experimental districts to let judges know what they think about the programs. The fourteen experimenting districts are northern and southern California, northern and southern Florida, northern Illinois, southern Iowa, Maryland, Massachusetts, eastern and western Michigan, western Pennsylvania, Puerto Rico, Rhode Island and western Texas.

Volunteer Lawyers' Services To Be Recognized By Supreme Court And Florida Bar

Lawyers who donate their services to the needy are being sought for public recognition by the Chief Justice of the Florida Supreme Court and The Florida Bar.

One attorney from each of Florida's 20 judicial circuits is eligible for recognition through The Florida Bar President's Pro Bono Service Award. An attorney also will be selected to receive the Tobias Simon Pro Bono Service Award from the Chief Justice. "Pro bono" is derived from the


"Pro bono" is derived from the Latin phrase pro bono publico, meaning for the good of the public." The purpose of both awards is to encourage more Florida lawyers to freely contribute their time and expertise providing legal services to people or organizations in their community who cannot otherwise afford those services.

Th awards will be presented on March 16, 1983. Supreme Court Chief Justice James E. Alderman, of Tallahassee and Florda Bar President James C. Rinaman, Jr., of Jacksonville, will make the presentations during ceremonies at the Florida Supreme Court in Tallahassee. Nominations of Lawyers in Broward County may be made by any person or organization before January 15, 1983, by contacting Ray Ferrero, Jr., Post Office Box 14604 Fort Lauderdale, FL 33302. Community leaders, service organizations and other civic groups are especially encouraged to assist the Chief Justice and the Bar in their efforts to recognize voluntary legal services to this area's needy citizens.

A lawyer is eligible for either award if he or she is an attorney practicing in Florida, and is not employed on a full-time basis by an organization which has as its primary purpose the provision of free legal services to the poor.

The nominee should be a lawyer who has provided direct delivery of legal services in civil or criminal matters with no expectation of receiving a fee to a client or client group that does not have the resources to employ compensated counsel.

The Florida Bar President's Pro Bono Service Award was established in 1981, to recognize individual service in specific Florida judicial circuits. The Tobias Simon Pro Bono Service Award, given by the Chief Justice, commemorates Miami civil rights lawyer Tobias Simon who died in February 1982. The Chief Justice's award is believed to be the first of its kind in the country conferring recognition of a state's highest court on a private lawyer for voluntary, free legal services to the poor.
