FOOTBALL BRAWL IS RESCHEDULED Sunday, March 20, 1983 2:30 P.M. — Holiday Park

The carnage that was to occur on February 13 in the Flag Football Game between Senior Lawyers/Judges and Young Lawyers Section was cancelled because of inclement weather and has been re-scheduled for March 20, 1983 at 2:30 P.M. at the football field fronting on East Sunrise Blvd. at Holiday Park on East Sunrise Blvd.

In spite of the fact that the decision to cancel the game was made by President Hugh T. Maloney and the undersigned Chairman, vociferous protests and unprintable remarks were made by various persons who showed up. Typical of the verbal abuse was by one appellate judge from the First District Court of Appeal who described Senior Lawyers/Judges who failed to show up as "poltroons." A Senior Lawyer found the entire incident disgusting because of the attendance of less than a full complement of Young Lawyers players. He said that the Young Lawyers' mamas didn't want their boys playing in the rain.

Because of the masterly diplomatic efforts of the President and the undersigned Chairman, a major brouhaha was averted. Contestant and rowdy spectators who were placated with assurance that the belligerents would be afforded yet another opportunity to have a go at it.

Therefore, efforts are underway with all deliberate speed to insure the conduct of the event on the field of honor after which there will be a picnic (Dutch) at Pavilion #1 that has been reserved for the occasion. Free beer will be generously provided.

As you can see, this affair has gotten somewhat out of balance.

PRESIDENT'S MESSAGE

There are approximately 2,600 lawyers in Broward County; 1,400, of which, are members of the Broward County Bar Association. Less than 200 have signed up for Broward Lawyers Care, our Pro Bono Program. Many attorneys state they do free work within their practice and, therefore, they don't feel they should subscribe to the Broward Lawyers Care Program. Almost every lawyer who has any practice ends up doing some free or low-fee work. This is not an excuse not to participate in the Broward Lawyers Care Program.

With 200 lawyers participating, it means that each of those lawyers will do an average of three or possibly four cases a year. If we had all members of the Bar signed up, it would mean a case approximately every two years. We will attempt to contact you and solicit your participation. Hopefully, you will participate.

In addition to the pro bono work that we are performing on behalf of Legal Aid., we have been solicited by Judge Spellman of the Federal Disrict Court, Southern District, to provide, on a pro bono basis, representation for 51 (approximately) unrepresented Haitians located in Broward County. Their claim is for asylum.

We are attempting to make available a crash educational program in immigration law with the help of Nova Law School and other lawyers and agencies throughout the nation. Once the program is in place, we will disseminate further information and solicit your support in this regard.

It would be nice to report to Judge Spellman that the Broward Bar responded and all Haitians have representation.

The Broward Bar has given tentative approval to a building program. For several years, funds have been accumulated for this purpose. It is hoped that with the help of all law-

yers in the county, sufficient funds can be raised to erect a Bar Building in the Courthouse vicinity which will provide facilities for all lawyers that will be in keeping with our needs and be a matter of pride. As this plan is formulated, further information will be forthcoming.

Your support of these programs is earnestly solicited.

SUPREME COURT CERTIFIES JUDICIAL POSITION

The Florida Supreme Court by an Order entered February 17, 1983 certified two additional County Judges for Broward County. In addition, the Court Requested the Legislature provide funds for three retired judges to be assigned to Broward County to attempt to reduce the backlog of cases in the Circuit Court.

As of December 31, 1982 the case backlog in the 17th Circuit stood at 50,582 cases. The State Court Administrator's projections show that filings in Circuit Court will exceed dispositions by more than 10,000 per year for each of the next three years. The projected backlog is 83,829 cases by December 31, 1985. An independent study of the Broward Judicial Complex by Swimmer, Cole, Martinez Curtis, a California consulting firm retained by the Broward County Commission confirmed these figures. It also confirmed the need for additional judges requested by Chief Judge Louis Weissing.

In further recognizing the problem of undisposed cases the Court ordered State Court Administrator Donald Conn to conduct a study in the Seventeenth Judicial Circuit to verify conditions and determine the cause and possible solution for the backlog problem. This study will be conducted in 1983.

Special Motion Calendar For For Temporary Pretrial Relief In Dissolution Cases

Effective March 25, 1983, and each Friday thereafter, the undersigned Judge will hear applications for Temporary pretrial relief in domestic matters from *ONE to TWO P.M. on FRIDAYS*. The following provisions apply:

- 1. Financial affidavits are required.
- 2. Cases are limited to 10 minutes.
- Counsel shall not make appointments with Judge's Judicial Assistant, but shall notice the opposing party in accordance with applicable statutes and Rules of Procedure.
- 4. A copy of the Notice of Hearing, Motion and Financial Affidavit shall be in the hands of the Judges's Assistant (not just the Clerk) four (4) days in advance of the hearing. This requirement may be relaxed if adequate notice is given to the opposing party and if the moving party hand-carries the file to the courtroom.
- Contempt and Post Trial matters will not be heard on this calendar and may be referred to the General Master.
- Effective March 18, 1983, no motions for pretrial relief will be referred to the General Master.
