## Broward Bar Foundation Adopts Program

Broward Bar Foundation President announced that the Foundation had adopted several new programs for the coming Bar year at its Board of Directors Meeting on April 6, 1983.

First and most important, the Broward Bar Foundation will seek a new building in the Courthouse area to house the activities of the Broward County Bar Association, The Florida Bar, Legal Aid and Broward Lawyers Care, and the Broward Foundation. The Foundation will work with the Special Bar Association Committee appointed by Association President Hugh Maloney. A survey of Broward Lawyers is planned to determine how many Broward Lawyers would financially support a Building Fund Drive and at what level.

A second project was to seek funds by way of grant from the Florida Bar Foundation to provide a Pro Bono Coordinator for Broward Lawyers Care. A related project is to obtain funds from the American Bar Association Young Lawyer's Section to provide training and material for volunteer Lawyers representing Haitians in immigration and related proceeding.

In other action the Broward Bar Foundation Board voted to:

- 1. Apply for Administration of Justice Grants from the Florida Bar Foundation to provide technical assistance to the Tri-County (Dade, Broward, Palm Beach) Judicial Council.
- 2. To cooperate with the Florida Bar Foundation in obtaining funds for distribution of American Bar Association Publication, Equal Justice under Law: The Supreme Court in American Lite.
- 3. To establish a Law Student Scholarship Program in cooperation

with Nova Law Center and The Florida Bar Foundation.

The foundation requested permission from the Broward County Bar Association to have a contribution check off on the 1983 Broward County Bar Association dues statement. This request was approved by the Broward County Bar Associaton Executive Committee. Each member will have the opportunity to contribute to the Broward Bar Foundation with his dues as of June 1, 1983.

#### SPECIAL MOTION CALENDAR FOR TEMPORARY PRETRIAL IN DISSOLUTION CASES

Judge J. Cail Lee and Judge Linda L. Vitale are participating in this program.

The rules for Judge Lee are;— Effective Friday, June 17, 1983, and each Friday thereafter, except those weeks when the Court is conducting jury trials, the undersigned Judge will hear, by SPECIAL AP-POINTMENT, Applications for EM-ERGENCY Temporary Pre-Trial Relief in Dissolution Cases from 10:00 A.M. - 11:00 A.M.

The following provisions apply:

- FINANCIAL AFFIDAVITS are required.
- 2. Cases are limited to ten (10) minutes per side, or for a total hearing time of twenty (20) minutes.
- 3. Counsel will reserve the time by making a special appointment with the Judicial Assistant, and shall notice the opposing party in accordance with applicable

for Temporary Pretrial Relief in domestic matters from 4:30 P.M. to 5:30 P.M. each Thursday.

The following provisions apply:

- 1. FINANCIAL AFFIDAVITS are required.
- 2. Cases are limited to 10 minutes per case.
- Counsel SHALL ALWAYS make appointments with the Judge's Judicial Assistant and shall notice the opposing party in accordance with applicable Statutes and Rules of Procedure.
- 4. A copy of the Notice of Hearing, Motion and Financial Affidavit shall be in the hands of the Judge's Assistant (4) days in advance of the hearing (not just the clerk). This requirement may be relaxed if adequate notice is given to opposing party and if the moving party has copies of the Financial Affidavit in the Judge's Assistant's hands no later than 3:00 P.M. on Wednesday.
- Contempt and Post Trial matters will not be heard on this calender and may be referred to the General Master.

This calendar is intended for short Motions for Temporary Relief that require an evidentiary hearing and disposition within less than (10) ten days. Short procedural matters and Exceptions to the Report of the General Master may be set on the Judge's regular motion calendar from 8:45 A.M. to 9:30 A.M. (Monday thru Thursday). Lengthy hearings for Temporary Relief and those which do not require expeditious relief will not be heard on this calendar and may be referred to the General Master.

## HIGH SCHOOL EDUCATION PROJECT REPORT

The Young Lawyer's Section of the Broward County Bar Association is concluding its High School Education Project for this school year. We contacted thirty-five area middle and high schools and also obtained the approval of the Broward County School Board Administrator's Office.

Some thirty-three attorneys lectured to classes at twenty-five schools and twenty-one more lawyers were involved in simulated trials in the areas of products liability, personal injury, criminal and business law.

The purpose of the project is to inform students about the law and familiarize them with the jury trial system. To this end, over 1,300 students have benefited from the program this year. This success is directly related to the experience and expertise of the fifty-four lawyers who volunteered their time. The program acknowledges its debt of gratitude to all those who participated. 

#### HAUNTED OFFICE?

What do "ghosts" and the regal profession have in common? They both share a part of the history of an historical building in downtown Fort Lauderdale. The old mansion at 1313 South Andrews Avenue, which is now the office of the husband and wife law firm of Anderson and Anderson, has had a very full and colorful past.

Frank Croissant, millionaire developer who made and lost a fortune in Florida real estate built the rambling two story Spanish style mansion in 1926. The Croissants lived in the mansion until their deaths in the early 1960's. Ownership of the building passed to a nephew and in 1972, it was sold and turned into *The Seed*, a drug rehabilitation center. Finally the building was sold and turned into a tourist attraction known as *The Haunted House*, complete with tombstones.

The house had been boarded and was rundown after being closed in 1979. Philip and Carol Anderson, who had practiced law in an office a few blocks away from the mansion decided to purchase the property and renovate the building for offices for their growing practice.

The building which is one of the oldest in the city, has been restored to its original grandeur. The mansion is painted bright yellow and features a flower box filled with red begonias outside Philip Anderson's window. A bell tower rests on the terra cotta barrel roof.

Inside, there are 14 foot high ceilings and the original wood floors have been restored and polished. A picture of the house when it was built is on

the mantle of a fireplace (one of two fireplaces) in the formal reception room.

The lot which was purchased with the house was large enough to provide plenty of parking as well as space for an additional building. The Andersons have constructed a very modern, all concrete, 10,000 square foot condominium office building to serve as a medical and law office complex. The complex is called Croissant Plaza.

The Andersons have received a plaque from the City for the restoration of the mansion and it was nominated for the City's beautification award. Thanks to the effort of the Andersons, who are members of our bar association, the restoration project has preserved a part of Fort Lauderdale's history.

#### Recently Admitted Broward Bar Members

As the current Administrative Judge of the County Court I would like to welcome the recently admitted Broward Bar members.

As you stand upon the threshold of your legal careers, if I were to offer you a word of advice, it would be this:

As an attorney you will be called upon to make decisions which will affect the most precious rights of your fellow citizens — decisions which will affect their lives, liberty and property.

It is not too much to say that the very survival of this Nation depends upon the efficient, effective, and objective administration of our Judicial System.

In your role in that context, I would encourage you never to forget Lord Coke's dictum;

"The certainty of the Law is the safety of all." Let that be the Rule which will govern your conduct as a lawyer — in your advice and counsel, set aside all emotion — prejudice and personal considerations. The Law will be your sword and your shield, which you will use in the battle to protect the rights of all with whom you deal as a lawyer.

Remember always that especially the County Court is the People's Court — the first and only Court with which most of your fellow citizens will ever come in contact. As they perceive your actions as a practicing trial lawyer so will they form their opinion — good or bad — of our Legal System.

From today forward, the Law must be your only Mistress and she is a jealous one. You must be her constant Suitor and Servant.

Kemember that in your private lives you will not be afforded the same tolerance enjoyed by other individuals. As an attorney the moral code which you will follow is not that of the market place, rather, the punctillio of honor must be your standard.

As you enter upon your task of assisting the Court System in dispensing Justice, be assured you have the best wishes and support of all the Judges in the Seventeenth Judicial Circuit and of all the people of Broward County, whom you will serve.

As for me, may I say that I shall always look with pleasure to be working with you, as attorneys in a professional and continuing association.

#### SPECIAL RECOGNITION

During the past year, 169 Broward attorneys volunteered to provide free legal service to the poor through Broward Lawyers Care. Each and every one of these attorneys deserves to be acknowledged for the many hours of free services they have donated. A special commendation, however, is in order for Attorney Eugene T. Gillis. Between June and December of 1982, he accepted four Pro Bono cases all involving contested divorces. He has already committed in excess of 30 hours to serve the poor. Mr. Gillis, a 1979 graduate of Nova Law School, is a sole practitioner in Fort Lauderdale. 
This pilot program will be available effective Monday May 2, 1983.
