

# Resolution of the Executive Committee of the Broward County Bar Association

As the designated representative of the Broward County Bar Association, President-Elect Terrence Russell appeared and made a presentation before the Article V Review Commission at public hearings conducted in West Palm Beach on September 15, 1983. Mr. Russell presented the Executive Committee Resolution appearing in this issue of the Barrister and answered questions from the Commission during a 45-minute dialogue which also included comments about the need for reform in the procedures of the Judicial Nominating Commissions.

The West Palm Beach hearings were well attended and informal conversations between some of the Commission members and Mr. Russell indicated that all of the Commission's hearings have generated a great deal of public interest. The Article V Review Commission was appointed recently by Chief Justice Alder-

man to recommend possible changes in Article V of the Florida Constitution.

The Commission, headed by Justice Ben F. Overton and including many distinguished lawyers and judges, among them District Court of Appeals Judge Gavin K. Letts, Senator Jim Scott, Attorney General Jim Smith, and Florida Bar President-Elect Gerald Richman, appeared genuinely interested in the position of the Broward County Bar Association, as reflected in the Resolution.

It is anticipated that the Article V Review Commission, which concludes its public hearings on September 16, 1983, in Miami, will make specific recommendations to the Chief Justice early in 1984.

Whereas, the Executive Committee of the Broward County Bar Association has adopted certain recommendations of the Committee and has thereby taken an official position with regard to same; and

Whereas, the President-Elect of the Broward County Bar Association has been designated by the Executive Committee to present the view of the Broward County Bar Association to the Article V Review Commission during the course of pending public hearings:

BE IT HEREBY RESOLVED AS FOLLOWS:

- That the Broward County Bar Association favors a study on the feasibility of expansion of the jurisdiction of the Florida Supreme Court.
- 2. That the Broward County Bar Association favors a study on the expansion of the jurisdiction and number of the intermediate Appellate Courts of this State.
- That the Broward County Bar Association is strongly opposed to the consolidation of County and Circuit Courts.

 That the Broward County Bar Association is opposed to the reestablishment of Municipal Courts.

 That the Broward County Bar Association is strongly opposed to requiring public meetings of the State's Judicial Nominating Commissions.

 That the Broward County Bar Association is opposed to public proceedings of the Judicial Qualifications Commission.

7. That the Broward County Bar Association is opposed to a mandatory retirement age for judges.

8. That the Broward County Bar Association is in favor of the establishment of specialized Trial and Appellate Courts and opposed to the "rotation system" for Circuit Court Judges among the presently existing divisions in the Circuit Court.

Duly adopted by the Executive Committee on the 12th day of September, 1983.

# Legislation of Interest to Attorneys

Copies of the Chapter Law for any of the following bills passed may be secured by writing to the Secretary of the Senate, The Capitol, Tallahassee, Florida 32301.

#### HB 1103—Workers' Compensation

Provides that the maximum fee schedule for medical treatment shall have statewide applicability and be uniform throughout the state; provides standards for adoption of the schedule, for membership of the panel appointed to determine fee schedules for medical treatment; provides staff support for the panel; and deletes a restriction upon the issuance of policies not containing a coinsurance provision.

Amends: Ch. 449,13 Effective Date: June 30, 1983

#### HB 1277—Workers' Compensation

Changes the types of communications exempt from administrative procedure; reiterates exclusiveness of liability provisions of workers' compensation laws; requires treatment and care for employees to be medically necessary, etc.

Amends: Ch. 440

Repeals: 440.021(9), .561(7) Effective Date: October 1, 1983

#### CS/HB 23-B—Mortgages

Amends provisions permitting mortgagees to record and secure obligations of more than 20 years when the original record of the obligation secured by a mortgage is not ascertainable from the record of it; eliminates requirement that certain mortgages be secured by a oneto-four family structure with respect to the law governing returns on intangible taxes and the law governing the documentary stamp tax on mortgages; revises penalties for failure to file required information with the Department of Revenue or with Stockholders; provides for application to the 1983 tax year; deletes a provision authorizing the mortgagor or his successor to file a notice limiting optional future advances; permits mortgagors or their successors in title to limit the principal amount secured by the mortgage and thereby preclude future advances; exempts negative amortization and construction loan agreements therefrom; provides a method for calculating the final payment on an adjustable rate balloon mortgage; requires disclosure, directs the Department of Community Affairs to conduct a study into the use of reverse annuity mortgages or similar instruments in this state; provides an exemption from balloon mortgage provisions, for mortgages in excess of \$500,000; and requires a written report to the legislature.

#### SB 261—Landlord and Tenant

Specifies alternative methods by which a landlord may recover possession of nonresidential premises; provides additional duties for certain services of summons for removal of a tenant; redefines "dwelling unit" for purposes of provisions relating to award of attorney's fees in actions relating to residential tenancies; changes the duties of residential landlords with respect to deposits and advance rents; requires the payment of interest to the tenant and provides procedure with respect thereto; expands certain exemptions from provisions regulating the use of such funds; changes the circumstances in which a residential tenancy may be terminated; relates to defenses to an action for rent or possession; expands the applicability of provisions requiring tenants to pay accrued rent into the court registry; requires certain notice; prohibits certain retaliatory conduct by a landlord against a tenant for specified actions by the tenant; defines "discrimination" for certain purposes therein; changes provisions relating to notice of violations by mobile home owners; changes the date for the issuance of writs of possession against mobile home owners; creates provisions for the "Disposition of Personal Property Landlord and Tenant Act"; provides procedures for the disposition of personal property left by a residential or commercial tenant; provides certain prerequisites to disposition; requires notification of tenant and specifies the form of notice; provides for the storage of abandoned property; authorizes the release of personal property by the landlord; provides procedures for the sale of abandoned property; exempts the landlord from certain liability after disposition of the property and for the assessment of the cost for storage.

#### SB 17-B—Crime Victims

Provides for the collection and distribution of certain costs and surcharges on criminal traffic offenses; directs payment of increased fines to the Crimes Compensation Trust Fund; and increases the costs imposed for certain offenses from \$10 to \$15 and including within such offenses the violation of certain municipal and county ordinances.

Amends: Chs. 316, 660,

775.0835, 960.20

Effective Date: July 7, 1983

#### CS/HB 208—Sheriffs—Fees and Service of Process

House Bill 208 doubles all fees for service of writs and executions. Witness subpoena fees are increased from \$7 to \$10. Permit fees for fire sales and going out of business sales are increased from \$25 to \$50. A new section provides that writs of attachment may be served on a third person where the property to be attached was in possession of the defendant at the time the writ was issued but passed to a third person before execution. Regarding replevin of property believed to be secreted or concealed in a house or building, the sheriff must have reasonable grounds to believe the property is so concealed before he may break into the building. If he does not have such reasonable grounds, the plaintiff may petition the court for a "break order."

Amends: Chs. 30, 39, 76, 78, 83, 559

Effective Date: October 1, 1983

#### HB 472—Garnishment

Provides for issuance of writs of garnishment before judgment, for dissolution of same, that no judgment in excess of amount remaining unpaid on final judgment against defendant or in excess of liability shall be entered against the garnishee.

Amends: Ch. 77.031, .07, .083 Effective Date: July 1, 1983

# CS/HB 885—Motor Vehicle Warranties—"Lemon Law"

Creates the "Motor Vehicle Warranty Enforcement Act"; requires new motor vehicles to conform to all applicable express warranties; provides requirements for the manufacturer when a new motor vehicle does not conform, penalties for bad faith claims and for an informal dispute settlement procedure.

Effective Date: October 1, 1983 (Chapter 83-69)

#### HB 1127—Patient Records

That medical records may be furnished to certain persons in specified cirsumstances.

Amends: Chs.359.017, 455.241 Effective Date; October 1, 1983

#### SB 47—Guardians

Permits a niece or nephew to be appointed in a durable family power of attorney and provides that a judge is not prohibited from acting as a guardian when he has maintained a close family relationship to the ward.
