Hugh T. Maloney Receives Award

Hugh T. Maloney was one of 17 Florida lawyers to receive The Florida Bar President's Pro Bono Service Award for his voluntary commitments in making free legal services available to the poor in Broward County. The purpose of the award is to "encourage lawyers to volunteer free legal services to the poor by recognizing those who make such public service commitments, and to communicate to the public some sense of the substantial volunteer services provided by Florida lawyers to those who cannot afford legal fees."

Mr. Maloney has devoted substantial time to the Broward Lawyers Care program, soliciting involvement from fellow attorneys and providing free legal services to individuals who could not be helped by area legal aid programs. At the same time, he maintained the highest number of cases assigned by Legal Aid—all contested domestic relations actions. Maloney was instrumental in obtaining legal counsel for virtually every Haitian in Broward County who had been unrepresented. He also is chairman of the Broward County Bar Association's Legal Aid Committee.

Low Cost Criminal Defense Lawyer Referral Program

On April 2, 1984, the Low Cost Criminal Defense Lawyer Referral Program began.

The purpose of the program is to provide a vehicle to those criminal defendants who cannot qualify for the public defender program and have virtually no monies to afford the normal fees charged by criminal defense attorneys in this community. Only court referred clients will be referred.

Four Judges have agreed to participate in the initial start-up. They are Judge Patricia Cocalis, Judge Leonard Fleet, Judge George A. Shahood and Judge Robert W. Tyson, Jr.

Approximately forty (40) lawyers are in the program. If you do criminal defense work and are interested in participating, you must be a member of Broward County Bar Association and the Criminal Defense Attorneys Association. Rules and applications may also be obtained from the BCBA office by calling 764-8040.

The program could not have materialized without the long dedicated hours given by Judge Patricia Cocalis, Jeffery Wasserman, Thomas Lynch IV, Robert Wills and Nina Jacobsohn.

Administrative Order No. 2.14.1

As amended January 31, 1984

AMENDING ADMINISTRATIVE ORDER NO. 2.14.1 REGARDING IN-TERNAL PROCEDURE RULES FOR THE 17th JUDICIAL CIRCUIT: DESCRIBING THE DUTIES OF THE DUTY JUDGE OF THE CIRCUIT CIVIL DIVISION OF THE 17th JUDICIAL CIRCUIT.

In accordance with the authority vested in the Chief Judge by Rule 2.050, Florida Rules of Judicial Administraiton,

ORDERED that Administrative Order No. 2.14.1 Section Captioned Emergency Matters, Inability of Judge to Act be amended to read as follows:

EMERGENCY MATTERS, INABILITY OF ASSIGNED JUDGE TO ACT AND DUTIES OF THE DUTY JUDGE OF THE CIRCUIT CIVIL DIVISION OF THE 17th JUDICIAL CIRCUIT

(a) Emergency applications for extraordinary relief, such as ne exeat, injunction, receivership, etc., or for the dissolution or modification of any injunction, receivership, or other order granting extraordinary relief, shall be made to the judge before whom the case is pending.

(b) The Chief Judge shall designate by order the alternates for the respective judges. If by absence, a judge shall be unable to perform any duty pertaining to his office, it shall be the duty of his alternate to hear all uncontested and emergency matters of such judge. If the judge to whom the case has been assigned is in the courthouse, litigants may not apply to his alternate for hearing.

(c) When the assigned judge and his alternates are away from the courthouse, litigants must then present emergency matters to the duty judge for that week. In the absence of the judge assigned, his alternate and the duty judge, litigants may then apply to any Circuit Court judge, during the weekday hours of 9:00

A.M.-5:00 P.M.

(d) The Chief Judge shall create a duty roster naming a duty judge in the civil division of the 17th Judicial Circuit, whose duty shall begin at 9:00 A.M. Friday and continue until 9:00 A.M. the following Friday. During such period, such duty judge shall always notify the Sheriff's Dispatcher of his or her whereabouts for emergency calls.

(e) After 5:00 P.M. during weekdays and on the weekends and holidays, all true emergency requests by lawyers or litigants, on cases already pending, shall be addressed to the assigned judge via the Sheriff's Dispatcher. If the assigned judge is unavailable, the lawyers or litigants in such cases shall address themselves to the Duty Judge via the Sheriff's Dispatcher.

(f) After 5:00 P.M. during weekdays and on the weekends and holidays, all true emergency requests by lawyers or litigants on cases not yet filed shall be addressed to the Duty Judge via the Sheriff's Dispatcher. Such cases shall be promptly filed on the next available filing day by the lawyer or litigant making the emergency request.

(g) All applications by lawyers or litigants in true emergency cases as contained in paragraphs (d), (e) and (f) above shall be made to the Sheriff's Dispatcher, who shall then notify the assigned judge or the duty judge, who will then return the call of the lawyer or litigant. In no event shall the Sheriff's Dispatcher give out the telephone number of any judge.

All other provisions of Administrative Order 2.14.1 remain in full force and ef-

Judge Lamar Warren

"Hyperactivity." Such is the trait 28-year bench veteran Lamar Warren holds responsible for his stubborn insistence to remain on the bench, after retiring four years ago.

Observing the docket which requires up to three weeks a month of his time, one would expect somewhat of a workhorse-not exactly the image his contradictory title conjures up. On call to any of the state's 22 circuits, Warren, as one of five of the Seventeenth Judicial Circuit's "retired" judges, is anything but.

Assigned with his consent to active judicial service upon retirement, Warren's objective as a retired judge is to relieve those judges finding themselves swamped by the burden of increased litigation. Judge Warren's duties are primarily to Broward County but he occasionally finds himself needed in Palm Beach, Dade and Monroe Counties; last month he was assigned to Palm Beach cases for five weeks, although he concludes this is a rarity.

And, as if his schedule were not demanding enough, in addition to a commitment to various community projects, Judge Warren has completed a number of courses in English, history, social studies and government at Broward Community College (where he also serves as an honorary trustee). Over 20 courses later, after reliving the challenge of final exams, theses and ink-stained writing callouses, Warren is still a firm believer in the absolute importance of continued education. As a judge and a student, Warren feels, "Most of us don't want to rust out, we want to wear out."

Appointed to the bench as Broward's second Circuit Judge by Fuller Warren in 1951, Judge Warren (no relation to that governor) came to Fort Lauderdale in 1946 from the office of Attorney General J. Tom Watson. Watson's decision to run for governor put the judge in the position to consider a move from the capital. "Fort Lauderdale seemed like the best place to be," and after two years of practice, Warren was made Broward County's Prosecuting Attorney.

Born September 27, 1910, this physician's son was encouraged at a young age to follow in his father's footsteps. However, after leaving the University of Florida where Warren was a member of Phi Delta Theta and later an honorary member of Phi Delta Phi Legal Fraternity, it was his desire to practice law which led him to forget the prospect of medical school and to pass the Bar in 1941.

As Broward's second Circuit Judge, Warren witnessed a period when the county "burst at the seams." In 1946-47, the county's population began to increase to such an extent that Warren remembers the circuit receiving a new judge every 18-24 months. Today, with a county of 2,950 attorneys, Warren is convinced that the residents of Broward County are receiving better justice than they have in the past, a benefit he feels is partly attributable to "a good strong bar" in

Broward County.

The growth never ceases to amaze him and it is this relentless surge of new blood to the Broward area that he counts responsible for the number of backlogged cases in the circuit. With 29 municipalities and their attendant problems, Warren believes the addition of more judges and access to more courtroom space would be beneficial, but it is his confirmed belief that a focus on arbitration is the answer to this natural reaction of the system to its ever-increasing burden. Reducing the number of cases that come to trial is a goal on which he has set his sights. Already, the judge is preparing a study on methods of arbitration in an attempt to devise a plan of solution.

Another problem Warren has analyzed is the simple fact that a growing number of better-educated and more-skilled attorneys with each graduating class has resulted in an increase in litigation.

In addition to his responsibilities as retired judge, Warren also serves as head of the state's 35 retired judges. He has served as state chairman of the Conference of Circuit Judges of Florida and as national chairman of the National Conference of State Trial Judges of the American Bar Association. He presently is serving his sixth year as a member of the editorial board of the ABA's publication entitled The Judges' Journal.

In former years Warren was president of the Jaycees and of Kiwanis and received both the Jaycee Distinguished Service Award and the Good Government Award. He was elected a member of The Florida Bar Foundation.

As chairman of the Broward County Law Library Committee for 13 years (1955-68), Judge Warren was instrumental in establishing Broward's first law library. Prior to its establishment, the county's attorneys were forced to travel to Dade County for use of an extensive law library. As past member of the Fort Lauderdale Library Advisory Board, Warren now serves as a member of he Broward County Library Advisory Committee and has been actively involved in the formation of downtown's eagerly awaited research library.

Married to the former Marcia White of his hometown of Palatka, Florida, the judge and wife have three children and seven grandchildren. Their vacations are spent at a cabin jointly owned with son Gordon, a local dentist, and son-in-law attorney Ron Anselmo in the mountains of North Carolina in a small community known as Wolf Laurel at which son-inlaw attorney Jeffrey Barker joins them. A member of the First Presbyterian Church, he has served as an elder for 30

Having heard cases in the fourth, eleventh, fifteenth, sixteenth, eighteenth and twentieth circuits in addition to the seventeenth circuit, Judge Warren is speaking from substantial experience when he advises his younger colleagues that "there are absolutely no shortcuts." Hard work is essential in Warren's eves in order to maintain self-esteem and it is his belief in constant preparation and study that allows him to say after 43 years of devotion to law that he, very simply, likes what he is doing and works hard at it.
