All qualified persons who are interested in applying to fill these vacancies may do so by obtaining the necessary application forms from the office of the Broward County Court Administrator and by returning the completed application to that office no later than 5 o'clock P.M. on October 15, 1985. In order to be considered, an applicant must have been a member of The Florida Bar for the five years preceding January 1, 1986, in good standing.

When Governor Graham makes the appointment to the Supreme Court, a vacancy will exist on the Fourth D.C.A., as all three names sent to the Governor are Judges on the Fourth D.C.A.

"Litigation Crisis"

The medical and legal professions have been rocked with one crisis after another over the past eleven years. However, no "crisis" is more real than the one right here in Broward County that is unique to us. Lawyers and doctors who are involved in litigation are drawing battle lines concerning depositions, court testimony and fees.

The doctors allege that they are not being paid by the attorneys; they are wasting their valuable time going to unnecessary depositions, and, more importantly, attending trial which is very time consuming when depositions could be used in lieu of trial. The lawyers, on the other hand, feel that doctors are charging exhorbitant fees, are requiring money to be paid in advance, and are refusing to go to court. Both sides have valid complaints and both sides have misused the system.

Litigation is a legal, not a medical, system. Doctors who are involved in injury cases must be prepared to give a deposition and attend trial. They certainly have a right not to accept litigation cases but they do not have a right to ignore a subpoena either for a deposition or to attend trial. More importantly, they do not have a right to set their fees unreasonably. The rules are clear that either a doctor or lawyer may request the court to set a professional fee and the court will do so. Courts, more often than not, set fees which are less than even the lawyers are normally willing to pay. What is the solution? Lawyers and doctors must communicate with each other prior to depositions and prior to trial to discuss and agree upon reasonable fees, locations of depositions and times for court testimony. Both sides must realize that the patient/client deserves ethical treatment

Resolution Supporting Creation of a Sixth District Court of Appeal in Broward County

by both his doctor and lawyer. We have a duty to this patient/client and fighting between ourselves only hurts that patient/client.

The Federal Trade Commission has stopped our Broward County Medical-Legal Committee from setting reasonable fee guidelines. The committee published a book after much arduous work for the sole purpose of assisting the medicallegal community to communicate and work out these problems. Unfortunately, problems have become worse.

There are certain facts which each side must accept. First, doctors are subject to a subpoena and must appear at a deposition at any designated place at any time. A subpoena is subject only to appropriate notice and this usually means four to five days advance notice. Doctors may be subpoenaed to trial also with appropriate notice but with no regard to the doctor's time problems subject only to legitimate emergency situations. Lawyers are personally obliged to pay a reasonable fee for depositions and for court time. Without prior agreement, a judge will set the fees. Lawyers do not want "unwilling witnesses" nor do doctors wish to be deposed out of their office at inconvenient times nor dragged to trial and allowed to sit in hallways waiting to be called. Lawyers also do not want pseudo emergencies to disrupt the schedule at the last minute. Communication is the way to a solution. However, doctors charging \$500 an hour and lawyers refusing to pay a reasonable fee of \$200 an hour will not solve the problem.

It is urged that lawyers and doctors personally discuss deposition and trial fees and times if their secretaries cannot reach an understanding. More importantly, this committee can be called to assist if both sides feel that the other is

not being reasonable but the final solution depends upon an ethical and reasonable approach to the medical and legal requirements of litigation. Fortunately or unfortunately, the legal system can dictate the times and places and fees but the lawyers prefer to continue handling litigation for the convenience of the doctors based upon reasonable fees and upon prior agreements and understandings. Please promote better communications and act with the highest code of ethics consistent with both professions. It is acknowledged that an uncooperative doctor may have emergencies or problems which would greatly inconvenience the lawyers and courts. It is hoped that through a real effort at improved communications in the spirit of cooperation the system can be made to function more smoothly for all parties concerned to the benefit of everyone including the patient/client.

Arbitration Garners Good Report

A recent study conducted by the Clerk's Office of the U.S. District Court for the Middle District of Florida revealed that the recently implemented Court Annexed Arbitration Program is performing quite well. The Middle District's arbitration program is the fourth of its kind in the federal system, and the first Federal Court sponsored arbitration program within the state.

The study concluded that 26% of the cases referred to the arbitration program were terminated within the first six months of the program as compared to a 30% termination rate for "control cases." In the future, the Court expects markedly higher termination rates for arbitration cases. This expectation is based upon a similar study conducted by the Federal Judicial Center in Washington, D.C. That study compared the termination rates for other federal court arbitration programs and concluded that substantially higher termination rates can be expected beyond the first six months of the program.

In addition to the program's early success in achieving comparable termination rates, the study also discovered that arbitration is having a profound effect upon the manner in which cases are terminated. The most striking evidence of the changing patterns was found in a 35% increase in voluntary case settlements prior to the actual arbitration

hearing. Another indicator of the success of the arbitration hearing process has been the striking similarity between "arbitration awards" and subsequent final judgments



of the court following a trial de novo demand by the party not prevailing at the arbitration hearing.

Recently a case which was heard by an arbitration panel only two months after the complaint was filed was subsequently decided by summary judgment seven months after the actual hearing. In that case, the losing party at the arbitration hearing had demanded a trial de novo, and under the Middle District's procedures the actual award was sealed to prevent disclosure of the arbitration award. It was significant to note that the judge's final judgment was identical to the sealed arbitration award. Such similarity between trial and arbitration awards will give added credence and acceptability to the program.

According to Mrs. Carolyn Weber, the Jacksonville Division Arbitration Coordinator, there are other benefits associated with the program, including an increasing awareness and acceptance of the program by the practicing attorneys, many of whom voluntarily serve as arbitrators.

Based upon the preliminary results of the study, the Court has determined that the arbitration program has initially achieved the goals established by the Court, namely to achieve the prompt and equitable disposition of cases while retaining the high quality of justice associated with more traditional methods of dispute settlement.


