## As I See It "Nobody's Laughing Now"

About this time last year, the Broward County Bar Association embarked on a project, which many of our friends referred to as wishful thinking, and which many of our critics found humorous. We believed then, and we have even more reason to believe now, that there is a need for a new Court of Appeals to be located in Broward County. With the help of our legislative delegation, especially Representative Tom Gustafson and Senator Ken Jenne, and with the concurrence of the Speaker of the House and the President of the Senate, Chief Justice Joe Boyd appointed the Appellate Court Restructure Commission on June 17, 1985. The Commission will be conducting public hearings in Broward County on September 20, 1985, in the County Commission meeting room at the new Governmental Center.

Here are some of the facts. On July 23, 1984, the Judges of the 4th DCA unanimously resolved to support the creation of a Study Commission for the purpose of determining the need for a 6th DCA in Broward County. Specifically, the Court said: "It is the sense of the Court that the Court believes that the proposal of the officers of the Broward County Bar Association for the creation of a Sixth District Court of Appeal to be headquartered

## Young Lawyers Section Flag Football

Two life sized bronze sculptures were unveiled in front of the Fourth District Court of Appeal on Thursday, June 20.

in Broward County offers the potential for relief from an expanding caseload and the attendant problems of assuring the effective administration of justice at the appellate level . . ."

The 4th DCA has the lowest criminal but the highest civil caseload of all Courts of Appeal in Florida. The 4th DCA, in 1984, disposed of more of its caseload with written opinions (including Per Curiam decisions) than any other District Court except the 1st District, which has twelve judges. The recommended caseload per Appellate Judge is 250. That number is materially exceeded in the 3rd, 4th and 5th Districts.

At the end of 1984, almost 60% of the 4th District's caseload, both civil and criminal, originated in Broward County, even though the 4th District encompasses six Counties (Broward, Palm Beach, Martin, Okeechobee, St. Lucie and Indian River).

The 1984 Kiplinger Forecast projects that population growth by 1994 among the Counties in the 4th District will be greatest in Broward County. Broward is expected to add 322,000 new residents, Palm Beach 240,000, Martin 34,000, St. Lucie 43,000 and Indian River 28,000 new residents. In 1984 alone, Broward County generated an Appellate caseload for the 4th District equivalent to 85% of the caseload of the entire 5th District, which has six judges, and encompasses 13 Counties.

It is imperative that Broward County's community leaders appear and express strong community support to the Commission when it holds its hearings on September 20. We are on a threshold of a great accomplishment and a well deserved success for all of the citizens of Broward County. We are absolutely certain that lawyers and community leaders from Palm Beach County will be present. It will be an important day for all of us.

One thing is for sure, nobody's laughing any more.

## 1985 Medical Malpractice "Reform"?

If Chief Justice Warren Burger remains vocal about not thinking much of trial lawyers, the jury system, and advertising, it is only a matter of time before he probably will be outspoken in large part against Chapter 85-175, the new Florida Legislation on medical malpractice. At least then, the Chief Justice will be, in this writer's opinion, 2 for 4.

The 1985 session of the Florida Legislature passed, and the Governor signed into law, on June 17, 1985, many changes that impact medical malpractice litigation. (See 1985 Session Law Services, West, pages 491-583.) I shall attempt to highlight only a few of the significant changes. Note that there are different effective dates for various sections. The new law is effective October 1, 1985, unless otherwise provided by the Legislature.

(1) Review and Discipline of Physicians.

The Department of Professional Regulation is required to investigate and discipline certain physicians and health care providers, for certain misconduct, S 495.015, F.S.; Osteopaths, S 627.4147, F.S.; and the Department of Insurance is to report certain information on health care providers to certain state agencies, S 768.40, F.S.

(2) Attorney Fees and Costs.

The trial court can review the attorney-client fee arrangement. Guidelines for reasonable fees are generally similar to factors outlined in DR-2-106, Canons. Also see, formulae laid out in F.P.C.F. vs. Rowe (Fla. 1985), May 2, 1985, 10 Florida Law Weekly 249. No attorney shall receive a fee "merely for referring a claimant to another attorney." A copy of S 768.575, F.S., must be given to a client when the contingency fee contract is entered.

Fee schedules are adopted, effective July 1, 1986, and expire October 1, 1988. Recoveries up to \$2 million result in a permissible fee from 15% to 45%, on an increasing scale, depending at what stage of the proceedings the case is resolved. Attorney fees of 15% of amounts over \$2 million shall be presumed reasonable and not excessive.

The Legislative schedule shall be, by legislative proclamation, deemed reasonable until the "Supreme Court" adopts guidelines. *Quere:* Is the ruling in the lodestar case, *Rowe*, such a pronouncement of guidelines, serving to negate the effect of S 768.575, F.S.?

A plaintiff prevailing in a suit based upon unnecessary diagnostic testing shall recover attorney fees. The present statute providing for attorney's fees to the prevailing party is repealed, effective October 1, 1985. S 768.56, F.S.

(3) Implied Consent.

Implied Consent, S 768.46, F.S., has been amended to provide that certain written consent forms shall raise only a rebuttable (and not conclusive) presumption of valid consent, consistent with a recent opinion of the District Court of Appeal.

(4) Financial Responsibility of Physicians.

As a condition of issuance or renewal of a physician's license to practice medicine, he *shall* demonstrate financial responsibility or coverage not less than \$100,000 per claim, and \$250,000 per claim for hospital privileges. S 458.320, S 459.0085, effective January 1, 1987.

(5) Attorney Investigation of Medical Malpractice Claim.

Plaintiff Counsel must make, prior to filing a case, "a reasonable investigation as permitted by the circumstances" to determine if there are "good faith" grounds to believe that negligence has occurred. S 768.495, F.S., Counsel must certify to same in the Complaint. A written opinion, not subject of discovery, of an expert as defined in S 768.45, F.S., that attests to the appearance of evidence of medical negligence, may establish "good faith." This is not the exclusive way to establish "good faith" belief of a claim, but is recommended anyway by good trial attorneys concentrating in medical malpractice. If the certificate is not made in good faith and no justiciable issue exists, the Court shall award attorney fees and costs 'against the plaintiff's counsel.'

Upon petition to the clerk of the court, an automatic stay of 90 days of the Statute of Limitations shall be granted to investigate the "good faith" factors.

Discovery of financial worth, pursuant to a punitive damage claim, shall only be permitted after the court has ruled and permitted such claim.

(6) Notice Before Filing Action, Arbitration, and Offers / Demands for Judgment.

Prior to filing a claim, a written notice of intent to file shall be sent to all prospective Defendants by certified mail, return receipt requested. No subsequent suit may be filed for 90 days, or 180 days if S 768.28(6)A) applies. Procedures for insurer review during this period are provided by statute. The insurer has the right to have Claimant appear at a "pretrial screening panel or before a medical review committee, and . . . a physician exam." Within the 90 or 180 days, the insurer must respond in writing as to its position on the claim. Upon receipt of same by Plaintiff's Counsel, the latter shall write the Claimant and advise of

several things. (See Session Laws, page 532.) Remember that the Statute of Limitations under 95.11, F.S., is tolled during this 90 or 180 day period. If negotiations cease, Plaintiff has either 60 days, or the balance of the time under the Statute of Limitations, whichever is greater, within which to file suit.

No products of the presuit screening process are discoverable or admissable in a subsequent civil suit; also note that "discoverable information" *shall* be made available to opposing side, if requested, in the presuit 90 day time, or the party failing to comply may have claims dismissed or defenses stricken.

An insurer may offer to admit liability and arbitrate damages, which can be accepted or rejected by the Plaintiff. (See Session Laws, pages 533-539 for procedures and time restrictions.) Arbitration provisions only apply to actions filed at least 90 days after October 1, 1985.

Court-ordered, not-binding arbitration may be requested by either party. S 768.575, F.S. This section may come to be known as the "aftermath of Carter vs. Sparkman and Albana vs. Hulub." This is not the old arbitration procedure, although it's similar. No findings of the arbitration are admissable in a subsequent civil trial. Time shall only tell the "value" of this additional procedure in handling claims!

Offers of Judgment and Demands for Judgment are permitted, and may give rise to recoverable attorney fees depending on whether the ultimate damage award is 25% higher or lower than the offer/demand, in a particular case. S 768.65, F.S.

- (7) Mandatory Settlement Conference. At least three weeks prior to trial a settlement conference must be held. S 768.58, F.S.
- (8) Periodic Payments of Judgment. Periodic payments of damages pursuant to judgment may apply to certain awards. This applies to judgments in lawsuits filed on or after October 1, 1985. S 768.51, F.S.

(9) Application of Legislation.

Except as otherwise provided, the law shall apply prospectively and "shall not apply to actions filed on or before the effective date."

The rule to remember, if you do medical malpractice: Be sure to *carefully read* this new creation of the Legislature.

#### **Elderly Law Unit**

The Elderly Law Unit at Legal Aid Service of Broward County, Inc., provides legal assistance to Broward County residents 60 years of age or older. The unit is committed to addressing the needs of the elderly poor in Broward County. In an effort to accomplish this goal, we have identified the areas of health and housing as the major priorities of the unit.

Most of our clients live on income solely from Social Security. With the rising costs of health care, they are frequently forced to spend a considerable portion of their income on health care costs to supplement the benefits available to them under Medicare. One of the goals of the Elderly Law Unit therefore is to ensure that our clients receive the Medicare and/or Medicaid benefits to which they are entitled with respect to hospital care, physicians' services, and nursing home care.

Recent legislative changes have enabled Medicare recipients to enroll in health maintenance organizations and obtain all their health care services from HMO. The elderly benefit from such a program because they do not have to bear the expense of deductibles and copayments associated with Medicare. However, we have seen numerous legal problems in this area because upon enrolling in the HMO the Medicare recipient relinquishes the right to obtain medical services from a non-HMO provider.

The two primary housing alternatives for the elderly poor in Broward County are public housing and mobile homes. Unit priorities therefore include increasing and maintaining the federally subsidized housing available for our clients. In addition, the unit is concerned with ensuring that conditions in existing public housing for the elderly are satisfactory. Because so many people residing in mobile home parks are elderly, the unit also identified the rights of homeowners and tenants in mobile home parks as a priority area.


